CONDITIONS ATTACHING TO IAPPPO/GEN/89/8

- A. Each consignment must be accompanied by a certificate in accordance with the terms of the Commission Decision 85/164 made under Council Directive 72/462/EEC, as amended, signed by an official veterinarian of the Government of the United States of America stating:—
- a. Details of consignment (species of animal, nature of cuts, nature of packaging, number of cuts or packages, net weight).
 - b. Address(es) and veterinary approval numbers of approved slaughterhous(es) and cutting plants.
 - c. Destination of meat (place of loading, country and place of destination, means of transport, names and addresses of consignor and consignee).

2. Health Attestation:

- 2.1 the fresh meat and offal described above is obtained from:
 - a. in the case of fresh meat from bovine animals, animals which have remained in the United States of America or in Canada for at least three months before being slaughtered or since birth in the case of animals less than three months old,
 - b. in the case of fresh meat from swine, sheep and goats, animals which have remained in the territory of the United States of America for at least three months before being slaughtered or since birth in the case of animals less than three months old,
 - c. in the case of fresh meat from swine, animals which have not come from holdings which for health reasons are subject to prohibition as a result of an outbreak of porcine brucellosis during the previous six weeks,
 - d. in the case of fresh meat from sheep and goats, animals which have not come from holdings which for health reasons are subject to prohibition as a result of an outbreak of ovine or caprine brucellosis during the previous six weeks.
- B. Any meat or offal imported under this licence shall be made available if so required for inspection by an Officer of the Ministry at any place nominated by him for such inspection. The importer or his agent shall afford all assistance necessary to such an officer to enable him to carry out the inspection in such manner as he shall determine and the importer shall be responsible for meeting any costs of carrying out such an inspection.

NOTES

3. Nothing in this licence gives exemption from any prohibition or restriction imposed by the Imported Food Regulations 1984 (as

amended) or the Medicines Act 1968 and 1971 or by any regulation superseding or amending the same, or any prohibition, regulation or restriction imposed by the Department of Trade and Industry.

- 4. This is not a Department of Trade and Industry Licence.
- 5. This licence will not be invalidated by transit of the products through any other country provided they are transported in sealed containers and provided that if the goods are examined by Customs en Route the containers are resealed and the documents are endorsed accordingly.

TREASURY MINUTE dated 4th July 1989

THE Lords Commissioners of Her Majesty's Treasury read Section 3(2) of the National Loans Act 1968 (1968 C.13 as amended) whereby any sums borrowed from the Public Works Loan Commissioners shall bear interest at such rates as the Treasury may determine from time to time in accordance with Section 5 of the said Act.

My Lords understand that the Public Works Loan Commissioners will be operating arrangements under which local authorities are permitted to borrow from the Commissioners up to a specified quota at a certain fixed rate of interest and in excess of such quotas at one of two higher fixed rates.

In accordance therewith the Chancellor of the Exchequer now recommends that with effect from 5th July 1989 and until the coming into operation of a further determination:

- I. The rate of interest applicable to any such fixed rate loan will be that in force on the day the authority applies to borrow or, if the application is before noon three working days before the loan is credited to the account of the authority's banker, the rate in force at 11 a.m. two banking days before credit day;
- II. Different rates of interest shall be charged on such fixed rate loans according to whether the principal of a loan is repaid by instalments or at maturity and, if repaid by instalments, whether by equal instalments of the principal with interest paid on the decreasing balance of the principal (E.I.P.) or by instalments of equal repayments of the principal and interest paid thereon (E.R.);
