## PROTECTION ORDER FOR THE RIVER DON AND PART OF THE RIVER URIE

- 1. IN terms of Paragraph 1 of Schedule 1 of the above Act, notice is hereby given that proposals for a Protection Order for the River Don and part of the River Urie have been submitted to the Secretary of State under Section 1 of the Act.
- 2. The general effect of the proposals is that, if implemented, they would result in a significant increase in availability of access to freshwater fishing in over 115 miles of the inland waters in part of the catchment area of the River Don and Urie at charges of £1.50 to £5.00 per day per rod, and would prohibit persons without legal right or without written permission from a person having such rights from fishing or taking freshwater fish in the inland waters to which the proposals relate. 
