It alters the conditions of landing with regard to wood, wood chips, particles of wood, wood waste or scrap of conifers grown in Canada, China, Japan, Korea or the United States of America and it prohibits the landing of fuel wood of conifers from those countries.

The Order also makes minor amendments.
