POST OFFICE

POST OFFICE SCHEME L2/1991

NOTE: The Scheme which follows this note is made under Section 28 of the Post Office Act 1969 and amends the Post Office Overseas Letter Post Scheme 1982. The Scheme, which comes into operation on the 18th March 1991, revises certain postal charges, introduces a European airmail small packet service and a European airmail printed packet service and abolishes the European airmail newspaper service, the reduced rate printed packet service and the facility for bulk posting in mail bags.

Additionally, the Scheme revises references to air letters, air mail packets, small packets, printed packets and literature for the blind.

(This note is not part of the Scheme)

THE POST OFFICE OVERSEAS LETTER POST AMENDMENT (NO.12) SCHEME 1991

The Post Office by virtue of the powers conferred upon it by Section 28 of the Post Office Act 1969 and of all other powers enabling it in this behalf, hereby makes the following Scheme:

Commencement and citation

- (1) This Scheme shall come into operation on the 18th March 1991 and may be cited as the Post Office Overseas Letter Post Amendment (No.12) Scheme 1991.
 - (2) This Scheme shall be read as one with the Post Office Overseas Letter Post Scheme 1982 (Post Office Scheme P2/1982) (hereinafter called "the Scheme") as amended by the Post Office Overseas Letter Post Amendment (No.1) Scheme 1982 (Post Office Scheme P6/1982), the Post Office Overseas Letters Post Amendment (No.2) Scheme 1983 (Post Office Scheme P4/1983), the Post Office Overseas Letter Post Amendment (No.3) Scheme 1984 (Post Office Scheme 3/ 1984), the Post Office Overseas Letter Amendment (No. 4) Scheme 1985 (Post Office Scheme 4/1985), the Post Office Overseas Letter Post Amendment (No.5) Scheme 1986 (Post Office Scheme 2/1986), the Post Office Overseas Letter Post Amendment (No.6) Scheme 1986 (Post Office Scheme 5/ 1986), the Post Office Overseas Letter Post Amendment (No.7) Scheme 1987 (Post Office Scheme 2/1987) the Post Office Overseas Letter Post Amendment (No.8) Scheme 1988 (Post Office Scheme 3/1988), the Post Office Overseas Letter Post Amendment (No.9) Scheme 1989 (Post Office Scheme L2/ 1989), the Post Office Overseas Letter Post Amendment (No.10) Scheme 1990 (Post Office Scheme L1/1990) and the Post Office Overseas Letter Post Amendment (No.11) Scheme 1991 (Post Office Scheme L1/1991).

Interpretation

- 2. (1) In sub-paragraph (1) of paragraph 3 of the Scheme as subsequently amended, the definition "air letter" shall be deleted and the following shall be substituted:
 - "aerogramme" means an air mail packet (not being a Forces aerogramme) consisting of a letter written on a special aerogramme form provided or approved by the Post Office'.
 - (2) In sub-paragraph (1) of Paragraph 3 of the Scheme as subsequently amended, the following definition shall be inserted after "aerogramme":
 - "Airmail Newspaper (HM Forces)" means a printed packet consisting of or containing one or more registered newspapers (and nothing else) which is posted as mentioned in paragraphs 7(1)(a)(b)(c) or (d) or is posted;
 - (a) on board a ship of the Royal Navy (whether on the high seas or in any port or place outside the British postal area) for transmission to an address in Europe or;
 - (b) by a member of the forces referred to in paragraphs 5(i)(ii) serving as therein mentioned, for transmission to an address in Europe."

- (3) In sub-paragraph (1) of paragraph 3 of the Scheme as subsequently amended, the definition "European Airmail Newspaper" shall be deleted.
- (4) In sub-paragraph (1) of paragraph 3 of the Scheme as subsequently amended, the following definition shall be inserted following "European Airmail Letters and Postcards":—
- "European Airmail Printed Packet" means an outgoing printed packet for transmission to any European destination and intended by the sender to be conveyed through any part of the post as a European Airmail Printed Packet, whether or not bearing any indication that it should be so conveyed.
- (5) In sub-paragraph (1) of paragraph 3 of the Scheme as subsequently amended, the following definition shall be inserted following "European Airmail Printed Packet":—
- "European Airmail Small Packet" means an outgoing small packet for transmission to any European destination and intended by the sender to be conveyed through any part of the post as a European Airmail Small Packet, whether or not bearing any indication that it should be so conveyed.
- (6) In sub-paragraph (1) of paragraph 3 of the Scheme, the definition "Forces air letter" shall be deleted and the following shall be substituted:
- "Forces aerogramme" means an air mail packet consisting of a letter written on a special Forces aerogramme form provided by the Post Office and addressed to, or sent to the British postal area by, a member of the armed forces of the United Kingdom serving abroad or on board a ship of the Royal Navy on the high seas or in any port or place outside the British postal area, or a member of the armed forces of any other Commonwealth country or of any State allied with the United Kingdom serving with British units or using a British Forces address;"
- (7) In sub-paragraph (1) of paragraph 3 of the Scheme as subsequently amended, the definition "literature for the blind" shall be deleted and the following shall be substituted:—

"literature for the blind" means

- books, papers and letters to or from blind persons impressed or otherwise prepared for use by the blind;
- papers sent to any person for impressing or otherwise prepared for that purpose;

and the following articles specially adapted for the use of the blind;

- (iii) Relief maps;
- (iv) Machines, frames and attachments for making impressions for the use by the blind;
- (v) writing frames and attachments;
- (vi) Braillette boards and pegs;
- (vii) De Braille instructional devices;

and the following articles which may be sent only to blind persons by organisations or institutions which have entered into special arrangements with the Post Office for sending these articles or to such organisations by blind persons;

- (viii) Games (including card games);
- (ix) Mathematical appliances and attachments;
- "Talking Books" and "Talking Newspapers", that is to say voice recordings on magnetic tape, disc, film or wire of either;
 - readings from printed books, journals, newspapers, periodicals or similar publications; or
 - (b) material which, although not necessarily printed, is of the nature of a book, journal, newspaper or similar publication and is not of the nature of a general entertainment programme; and apparatus designed to play such recordings;
- (xi) Metal plates impressed, or sent for impressing, for use by the blind;
- (xii) Supplies of wrappers, envelopes and labels for sending articles for use by the blind;

- (xiii) Watches, clocks, timers, tools, aids, precision instruments, rules and measures designed for use by the blind;
- (xiv) Sectional or collapsible walking sticks;
- (xv) Harness for guide dogs.
- (8) Sub-paragraph (2) of paragraph 3 of the Scheme shall be deleted and the following shall be substituted:
- "(2) In Schedule 3, the following expressions used in relation to a postal packet of any class or description have the meanings hereby respectively assigned to them:

"to Zone 1" means addressed to a country or place specified in Part 1 of Schedule 4:

"to Zone 2" means addressed to a country or place specified in Part 2 of Schedule 4."

Reduced rate printed packets

3. Paragraph 6 of the Scheme shall be deleted

Other printed packets and small packets

 Paragraph 7 of the Scheme, as subsequently amended shall be deleted and the following shall be substituted.

"Other printed packets and small packets

- 7. (1) Postage at the rates specified in Parts 1 and 5 of Schedule 2 shall be charged and paid on all printed packets posted:
 - (a) in the British postal area for transmission to those persons mentioned in paragraphs 5(1)(i) and (ii); or
 - (b) on board a ship of the Royal Navy (whether on the high seas or in any port or place outside the British postal area) for transmission to a person in the British postal area; or
 - (c) by a member of the forces referred to in paragraph 5(1)(ii) serving as therein mentioned, for transmission through a British Forces Post Office at which British postage stamps are issued, to a person in the British postal area; or
 - (d) on board a ship registered in any part of the British postal area while the ship is on the high seas, for transmission to the persons mentioned in paragraphs 5(1)(i) and (ii), wherever they may be stationed.
 - (2) Postage at the rates specified in Part 2 of Schedule 2 shall be charged and paid on European Airmail Printed Packets.
 - (3) Except as otherwise provided by sub-paragraphs (1) and (2) of this paragraph, postage at the rates specified in Part 3 of Schedule 2 shall be charged and paid on outgoing printed packets and on outgoing small packets.
 - (4) Postage at the rates specified in Part 4 of Schedule 2 shall be charged and paid on European Airmail Small Packets.
 - (5) This paragraph does not apply to air mail packets.

"Air mail packets

- 5. Paragraph 9 of the Scheme, as subsequently amended, shall be deleted and the following shall be substituted:
 - "9. There shall be charged and paid;
 - (a) on every aerogramme, postage of 32p
 - (b) on every Forces aerogramme, postage of 17p
 - (c) on other air mail packets, postage at the rate specified in Schedule 3"

Bulk posting in mail bags

6. Paragraph 10 of the Scheme shall be deleted.

Limits of weight and size

7. In sub-paragraph (1)(b) of paragraph 14 of the Scheme, the words "paragraph 6 or" shall be deleted.

Printed Packets

8. — (1) Sub-paragraph (1) of paragraph 22 of the Scheme shall be deleted and the following shall be substituted:

"Printed Packets

- 22. —(1) The expression "printed packet" in this Scheme means a packet consisting of or containing only:
 - (a) articles or documents (whether printed, engraved, lithographed, mimeographed or photographed) of any of the following descriptions;
 - (i) newspapers and periodicals, books and pamphlets;
 - (ii) sheets of music (except perforated sheets intended to be used with automatic musical instruments), visiting cards, address cards, and proofs of printing, with or without the relative manuscript;
 - (iii) engravings, photographs and albums containing photographs;
 - (iv) pictures and drawings, plans, maps and patterns intended for cutting out;
 - (v) brochures, prospectuses, advertisements, catalogues and notices.
 - (b) impressions or copies obtained upon paper or other similar material by means of painting, engraving, lithography, mimeography, photography or typewriter, or any other mechanical process easy to recognise, except impressions or copies obtained by means of tracing or a stamp with or without moveable type; but does not include a packet consisting of, or containing, literature for the blind.

Provided that a packet may be transmitted as a printed packet notwithstanding that in addition to any such things as are described in (a) and (b) above there is enwrapped or enclosed therein:

- (i) a card, envelope or wrapper for reply bearing the printed name and address (in the country or place in which the packet containing it was posted or to which it was sent) of the sender or his agent and having either postage stamps or postal prepayment impressions of the country or place to which such packet is addressed properly affixed thereto by way of payment of the return postage, or a suitable space for the proper fixing of such stamps;
- (ii) if the only other things so enwrapped or enclosed are printed literary or artistic productions, an open invoice (the terms whereof are such only as are necessary to its essential function as an invoice), with or without copies of the invoice, a delivery bill or international or internal money order forms of the country of destination, which notes or forms may indicate by any means the amount to be deposited or paid and the particulars of the postal giro account or the address of the beneficiary of the order.
- (2) In sub-paragraph (5) of paragraph 22 of the Scheme as subsequently amended, the amount "£20" shall be deleted and "£25" inserted in its place.
- (3) Sub-paragraphs (7), (8) and (9) of paragraph 22 of the Scheme as subsequently amended shall be deleted and the following shall be substituted:
- "(7) Every packet posted for transmission as a printed packet shall be conspicuously marked "Printed Papers" on the lefthand side of the space above the address.
- (8) Books and brochures made up in such a way as is specified in sub-paragraph (4) of this paragraph may be sealed in closed transparent wrappings".

Despatch of certain printed packets

- 9. Paragraph 23 of the Scheme, as subsequently amended, shall be deleted and the following shall be substituted:
- "23. Without prejudice to the generality of paragraph 43, any printed packet may be withheld from dispatch until any subsequent despatch".

Small packets

10. Paragraph 24 of the Scheme shall be deleted and the following shall be substituted:

- "24. —(1) The expression "small packet" in this scheme means a packet which contains goods and contains or bears no letter, note or other communication save such as may be expressly required or permitted by the following provisions of this paragraph.
 - (2) A packet may be transmitted as a small packet:
 - (a) if it contains in addition to goods
 - an open invoice relating to such goods, the terms whereof are such only as are necessary to its essential function as an invoice;
 - (ii) any other document having the character of current personal correspondence;

Provided that the sender and intended recipient of the document are respectively the same persons as the sender and addressee of the packet;

- (b) if it bears on the outside thereof, or on a sheet of paper enclosed therein, or on any of the goods therein, words, figures or symbols indicating all or any of the following:
 - (i) the address of the sender and addressee with the indications in use in commercial traffic;
 - (ii) a manufacturer's trade mark;
 - (iii) a bare reference to correspondence exchanged between the sender and the addressee relating to the goods;
 - (iv) the identity and address of the manufacturer and the supplier of the goods or the person for whom they are intended;
 - (v) serial or registration numbers of the goods, prices and particulars relating to the weight, volume and size thereof and quantity of such goods available and further particulars necessary to determine the source and character of the goods.
- (3) Every packet posted for transmission as a small packet shall be clearly marked "Small Packet" on the left-hand side of the space above the address, and shall bear the necessary customs declaration.
- (4) (i) Subject to sub-paragraphs (5) and (6) and the following provisions of this sub-paragraph, small packets may be sealed.
 - (ii) Except as the Post Office may allow, small packets must be made up in such a way that they can be easily be examined if posted:
 - (a) in the British postal area for transmission to the persons mentioned in paragraph 5(1)(i) and (ii); or .
 - (b) on board a ship of the Royal Navy (whether on the high seas or in any port or place outside the British postal area) for transmission to a person in the British postal area; or
 - (c) by a member of the forces referred to in paragraph 5(1)(ii) serving as therein mentioned, for, transmission through a British Forces Post Office at which British postage stamps are issued, to a person in the British postal area; or
 - (d) on board a ship registered in any part of the British postal area while the ship is on the high seas, for transmission to the persons mentioned in paragraphs 5(1)(i) and (ii), wherever they may be stationed.
- (5) An article in one piece, such as a piece of wood or metal, which it is not the custom in the trade to pack, need not be packed provided that the address is indicated (with the words "Small Packet") on the article itself if possible or (if not) on an address label).
- (6) Articles of glass or other fragile materials and packets containing liquids, oils, fatty substances, dry powder, live bees, leeches, silkworms' eggs, parasites or destroyers of noxious insects, shall be packed in accordance with such rules as may be prescribed.

- (7) In this paragraph, the expression "goods" includes things of the following descriptions:
- (a) gramophone records and tapes and wires of a kind used for recording sound or visual images:
 - (b) automatic data processing wires;
 - (c) magnetic tapes or wires;
 - (d) QSL cards.

Air mail packets

11. In sub-paragraphs (2) and (3) of paragraph 26 of the Scheme, the words "air letter" shall be deleted wherever they occur and "aerogramme" inserted in their place.

Transmission in bulk

1.

12. Paragraph 30 of the Scheme shall be deleted.

Compensation for certain other postal packets

13. In sub-paragraph (1) of paragraph 37 of the Scheme as subsequently amended, the words "or a European Airmail Newspaper" shall be deleted.

Rates of postage on letters and postcards other than air mail packets.

14. Part 2 of Schedule 1 to the Scheme as substituted by the Post Office Overseas Letter Post Amendment (No. 11) Scheme 1991 shall be deleted and the following shall be substituted:
