LAMBHILL RIGHT OF WAY APPLICATION 1991

1. NOTICE is hereby given that the British Coal Corporation in connection with the working of coal by opencast operations propose to apply under Section 15 of the Opencast Coal Act 1958 to the Secretary of State for an order suspending a public right of way as described in the Schedule below.
2. Opencast planning permission for the working has been granted.
3. A copy of the application and of a map showing the right of way can be inspected at the office of British Coal Opencast, Lambhill Opencast Site, near Blairingone, between the hours 9 am and 4.30 pm on Mondays to Fridays inclusive from 26th April 1991 to 31st May 1991.
4. No alternative right of way is to be made available.
5. Written objections, stating the grounds on which objections are made, may be sent by any person to the Secretary of State before 31st May 1991 at New St. Andrew's House, Edinburgh EH1 3SZ. If the local authority in whose area any part of the right of way lies objects and do not withdraw their objection the Secretary of State must arrange a public inquiry; if any other person objects and does not withdraw his objection he may arrange a public inquiry if he thinks fit.

RIGHT OF WAY TO BE SUSPENDED

Part of a public right of way, near Blairingone, which runs from Pitfar Lodge on The Goat Road approximately 900 metres east of the junction of The Goat Road and the A977, in a generally southerly direction along the Old Drove Road to a point on the unclassified road which joins Easter Muirhead and Cairnfold farmsteads, 500 metres east of Easter Muirhead farmstead. Being that part which extends from a point in Lambhill Wood 300 metres south of Pitfar Lodge to a point approximately 700 metres north-east from its junction with the unclassified road which joins Easter Muirhead and Cairnfold farmsteads.

RATES OF INTEREST ON LOANS BY THE PUBLIC WORKS LOAN COMMISSIONERS TO LOCAL AUTHORITIES

NOTICE

TREASURY MINUTE dated 30th April 1991

THE Lords Commissioners of Her Majesty's Treasury read Section 3(2) of the National Loans Act 1968 (1968 C.13 as amended) whereby any sums borrowed from the Public Works Loan Commissioners shall bear interest at such rates as the Treasury may determine from time to time in accordance with Section 5 of the said Act.

My Lords understand that the Public Works Loan Commissioners will be operating arrangements under which local authorities are permitted to borrow from the Commissioners up to a specified quota at a certain fixed rate of interest and in excess of such quota at one of two higher fixed rates.

In accordance therewith the Chancellor of the Exchequer now recommends that with effect from 1st May 1991 and until the coming into operation of a further determination:

- I. The rate of interest applicable to any such fixed rate loan will be that in force on the day the authority applies to borrow or, if the application is before noon three working days before the loan is credited to the account of the authority's banker, the rate in force at 11 am two banking days before credit day;
- II. Different rates of interest shall be charged on such fixed rate loans according to whether the principal of a loan is repaid by instalments or at maturity and, if repaid by instalments, whether by equal instalments of the principal with interest paid on the decreasing balance of the principal (E.I.P.) or by instalments of equal repayments of the principal and interest paid thereon (E.R.);
- III. The rates of such interest shall be:—

PWLB Non-quota A Rate loans will bear interest at 1 per cent above the corresponding Quota rates.

PWLB Non-quota B Rate loans will bear interest at 2 per cent above the corresponding Quota rates.

The amount which a local authority borrows within its annual quota will bear interest at the appropriate rate in the quota set of rates. Authorities may borrow further sums at quota rates at the discretion of the Public Works Loan Commissioners. Other borrowing beyond
