This Order makes provisions for the implementation of Council Directive 82/894/EEC (OJ No. L378, 31.12.82, p.58) as supplemented by Commission Decision 89/162/EEC (OJ No. 61, 4.3.89, p.48) which requires Member States to notify the Commission and other Member States of outbreaks of the first six diseases mentioned in the Schedule (and also various diseases already notifiable under animal health orders). This Order also applies to Viral Haemorrhagic Disease where it affects rabbits.
