In the event of a decrease in the Retail Prices Index (the RPI is explained in paragraph 6 of the first prospectus, paragraphs 13, 14 and 15 of the second prospectus and paragraphs 13, 14 and 15 of the third prospectus) the value of a certificate at an anniversary date will never be less than an amount equal to

(i) its value at the immediately preceding anniversary date, together with

(ii) interest at the variable rate earned since the immediately preceding anniversary date.

4. Paragraph 6 of the first prospectus or paragraphs 13, 14 and 15 of the second prospectus or paragraphs 13, 14 and 15 of the third prospectus shall apply to the calculation under paragraph 3 above.

5. (a) Until a new rate of interest is determined in accordance with sub-paragraph (b) below, the rate of interest to accrue on each anniversary in accordance with paragraph 3 above shall be 0.5% pa.
