GRAMPIAN REGIONAL COUNCIL
TORRY AREA TRAFFIC MANAGEMENT

THE Grampian Regional Council proposes to make The Grampian Regional Council (Torry, Aberdeen) Traffic Management Order 19 , under Sections 1(1) and (2) and 2(1) to (4) of the Road Traffic Regulation Act 1984.

The effect of the order will be to regulate the waiting of vehicles on specified lengths of those roads listed in the schedule to this notice and to revoke existing waiting restrictions on specified lengths of South Esplanade West and Menzies Road.

Exemptions to the restrictions will permit waiting:

- (1) for the purpose of picking up or setting down passengers;
- (2) for the purpose of loading or unloading goods;
- (3) where necessary in connection with any building operation or demolition; the removal of any obstruction to traffic; the maintenance of roads or the supply of gas, electricity, water or telegraphic services;
- (4) to enable a vehicle owned by a funeral undertaker, or owner of a funeral vehicle to be used for a purpose connected with a funeral, but only on occasions when it cannot conveniently be used for such purpose on any other roads;
- (5) by disabled drivers.

Also the proposed order will prohibit vehicles from travelling other than in a northerly direction on Walker Place, Aberdeen, and impose 7' width restrictions on Baxter Street, Abbey Road, Abbey Place and Ladywell Place. It is also proposed to close the central

reserve on Wellington Road to the south of Balnagask Road. and to revoke existing loading restrictions on specified lengths of Menzies Road, South Esplanade West and Victoria Road.

Full details of the proposal are contained in the draft order, which, together with a map showing the lengths of road affected and a statement of the Council's reasons for proposing to make the order, may be examined during normal office hours in the Roads Department, Woodhill House, Westburn Road, Aberdeen, and at the offices of the Divisional Road Surveyor, St. Nicholas House, Broad Street, Aberdeen.

Any person wishing to object to the proposed order should send details of the grounds for objection in writing to the undersigned by 3rd September 1991. Objections should state the name and address of the objector, the matters to which they relate and the grounds on which they are made.
