This licence is valid for imports of porcine semen collected and processed in a Member State from 1 January 1992 until revoked by the Secretary of State for Scotland.

This licence comes into force with effect from 1 January 1992.

CONDITIONS FOR THE IMPORTATION OF PORCINE SEMEN COLLECTED AND PROCESSED ON OR AFTER 1 JANUARY 1992 UNDER GENERAL LICENCE

1. All landings of semen shall be in accordance with the provisions of the Importation of Embryos, Ova and Semen Order 1980 (as amended) and with the following provisions of this licence.
2. Each consignment of semen shall be accompanied by an animal health certificate in accordance with Commission Directive 90/429/EEC (published in Official Journal No L 224/62 of 18/8 1990), signed by an official veterinarian of the exporting country. The certificates must state that the semen was collected from boars on a collection centre which contains only animals that have not been vaccinated against Aujeszky's disease and which have reacted negatively to the semen neutralisation or to the ELISA test for Aujeszky's disease in accordance with the above Directive.
3. The consignment of semen shall be transported in a flask sealed in the presence of the certifying veterinary officer.
4. The flask shall be clearly marked with the name and address of the dispatching collection centre and the number(s) of the animal health certificate(s) referred to at 2 above.
5. Consignees must notify, in writing, at least 24 hours in advance of the expected date of import, the local Divisional Veterinary Officer of the Ministry of Agriculture, Fisheries and Food, of their intention to import semen, in particular the nature of the consignment and the anticipated arrival date.
6. The animal health certificate must be presented on entry to HM Customs and Excise for checking and endorsement and then accompany the consignment to its final destination where it should be retained for a minimum period of 12 months for presentation to the Ministry of request.

NOTE

This licence applies only to consignments of porcine semen collected and processed in Member States on or after 1 January 1992. Any person wishing to import porcine semen collected and processed before 1 January 1992 should apply for a specific import licence to the appropriate address below: -

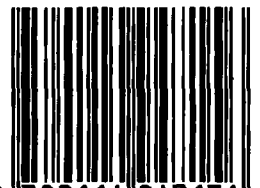
