- 5. Any person with custody or control of the apparatus at any time while it is in the United Kingdom and the importer shall keep a record in writing of the following in relation to the apparatus:
 - a) the model number;
 - b) the number in the consignment;
 - c) the date of import;
 - d) if acquired in the United Kingdom, the date of purchase;
 - e) if disposed of in the United Kingdom, the date of disposal and the name and address of the purchaser; and
 - f) in the case of the person who re-exports, the date of export and the completed consignment note confirming export.

for a period of 12 months from the date of purchase or import of the apparatus as the case may be or, in the case of the consignment note confirming export, for a period of 12 months from the date of export and shall make such records available for inspection on demand by a person authorised for that purpose by the Secretary of State.

- This Authority shall remain in force until it is revoked by the Secretary of State by means of a further notice in the London Gazette.
- 7. Words and expressions used in this Authority shall have the same meaning as they have in the Order.
- 8. The Interpretation Act 1978 shall apply for the purposes of interpreting this Authority as if it were an Act of Parliament.
