The effect of this is that paragraphs 6 and 7 of Schedule 5 to the Act will apply to the Trust Deed. Briefly, this has the effect of restricting the rights of the non acceding creditors to do diligence (ie. to enforce Court decrees for the unpaid debts) against the debtors and confers certain protection upon the Trust Deed from being superseded by the sequestration of the debtors' estates in respect of the partnership debts.
