NOTICE OF DISCLAIMER OF BONA VACANTIA

THE COMPANIES ACT 1985

WHEREAS James Craig (Transport) Limited was dissolved on the 7th of March 1989 in terms of Section 652 of the Companies Act 1985.

And whereas in terms of Section 654 of the said Act all property and rights whatsoever vested in or held on trust for a dissolved company immediately before its dissolution are deemed to be *bona vacantia*.
