CUSTOMS & EXCISE  
VALUE ADDED TAX

Treasury Directions dated 6th March 1996 under section 41(2), (5) and (6) of the Value Added Tax Act 1994 (c.23) as to the supply of goods or services by Government departments, between Government departments and by Government departments to the Crown Estate Commissioners.

THE A1 TRUNK ROAD LEMINGTON-HOWBURN  
DUALLING COMPULSORY PURCHASE ORDER 1996

NOTICE is hereby given that the Secretary of State, in exercise of the powers conferred on him by the above-mentioned Acts, on the twenty-ninth day of March 1996, made a Compulsory Purchase Order entitled "The A1 Trunk Road Lemington-Howburn Duelling Compulsory Purchase Order 1996".

The Order provides for the purchase of the lands described in the Schedule hereto in the Parish of Coldingham in the County of Berwick, for purposes connected with the dualling of a length of the A1 Trunk Road south east of Houndwood Village.

Copies of the made Order and relative plan may be inspected free of charge, during business hours from 12th April 1996 until 24th May 1996 at the offices of The Scottish Office Development Department, Victoria Quay, Edinburgh; Scottish Borders Council, Regional Headquarters, Newtown St Boswells, Melrose and Reston Post Office, Reston, Berwickshire.

The Order as made becomes operative on the twelfth day of April 1996, but if application is made to the Court of Session under paragraph 15 of the first Schedule to the Acquisition of Land (Scotland) Act 1947, as extended by Section 60 of the Land Compensation (Scotland) Act 1973, within a period of six weeks from that date by any person aggrieved by the Order who desires to question the validity thereof, the Court of Session may, by interim order, suspend the operation of the Order or any provision contained therein, either generally or in so far as it affects any property of the applicant, and may, if satisfied that the authorisation granted by the Order is not empowered to be granted or that interests of the applicant have been substantially prejudiced by any requirement of the said Schedule or of any regulation made thereunder not having been complied with, quash the Order or any provision contained therein either generally or in so far as it affects any property of the applicant.

The Secretary of State may acquire the land and the rights to the land to which this Notice relates by making a General Vesting Declaration under Section 278 of the Town and Country Planning (Scotland) Act 1972. Such a declaration shall not be executed before the end of the period of 2 months beginning with the date of the first publication of this Notice except with the consent of every occupier of the land affected. The effect of the making of such a declaration is to vest the land and the rights in land in the Secretary of State at the end of the appropriate period and is more fully explained in Form 9 contained in the Compulsory Purchase of Land (Scotland) Regulations 1976 (SI 1976 No. 820). A copy of the said Regulations has also been deposited and may be seen as aforesaid.

SCHEME MADE IN ACCORDANCE WITH PARAGRAPH 9  
OF SCHEDULE 2B TO THE GAS ACT 1986

INTRODUCTION

1. This scheme is made by British Gas plc in its capacity as the holder of a licence treated as granted under Section 7 of the Gas Act 1986 (the 1986 Act), as amended by the Gas Act 1995 (the 1995 Act), (British Gas TransCo) pursuant to the requirements of paragraph 9(3) of Schedule 2B to the 1986 Act and shall be effective on and from the appointed day under Section 18(2) of the 1995 Act and shall continue to have effect unless and until revised pursuant to the said paragraph 9(3) of Schedule 2B to the 1986 Act.
2. This scheme shall apply where:
  - (a) any person takes a supply of gas which is in the course of being conveyed by British Gas TransCo; or
  - (b) both
    - (i) any person at premises which have been reconnected in contravention of paragraph 11(1) of Schedule 2B to the 1986 Act takes a supply of gas which has been conveyed to these premises by British Gas TransCo; and
    - (ii) the supply is taken otherwise than in pursuance of a contract made with a gas supplier, or deemed to have been made with such a supplier by virtue of paragraph 8 of Schedule 2B to the 1986 Act or paragraph 19 of Schedule 5 to the 1995 Act,

for the purpose of determining the number of therms or kilowatt hours of gas represented by a supply so taken and the persons by whom such gas is taken.

DETERMINATION OF NUMBER OF THERMS OR  
KILOWATT HOURS TAKEN

3. Where this scheme applies British Gas TransCo will determine the number of therms or kilowatt hours taken in the circumstances set out in paragraph 2 above in accordance with paragraphs 4 to 7 below.
4. British Gas TransCo will determine the period during which gas was taken in the circumstances set out in paragraph 2 above having regard to such relevant information as is in its possession or as it may readily obtain, including such information as may from time to time be provided by suppliers and shippers, and to all the factors of the case which it considers relevant, including (where appropriate):
  - \* available consumption history;
  - \* the date of removal of any meter where any relevant premises have been disconnected by British Gas TransCo or cut off by a gas supplier;
  - \* the date when additional site-works at any relevant premises were completed if accompanied by no increase in consumption;
  - \* any change in occupier or owner of any relevant premises and the date on which that event took place;
  - \* the date after which there was no relevant shipper or gas supplier in relation to any relevant premises;

- \* information provided by any owner or occupier at any relevant premises;
- \* the date of the last meter reading;
- \* the date on which additional gas appliances were installed at any relevant premises if accompanied by no increase in consumption;
- \* irregularities in the pattern of pre-payments for gas in respect of any relevant premises;
- \* the date on which it appears to British Gas TransCo that the taking of gas ceased.

5. Where a supply of gas is taken:
- (a) in the circumstances set out in Paragraph 2(a) above for consumption at any premises; or
  - (b) in the circumstances set out in paragraph 2(b) above at such premises as are there mentioned,
