A814 GARELOCHHEAD BYPASS

THE SECRETARY OF STATE gives notice that he has made the following Order under section 5(2) of the Roads (Scotland) Act 1984:

The A814 Garelochhead Bypass (Detrunking) Order 1997 to provide for the detrunking of a length of road in the local government area of Argyll and Bute.
