#### THE A87 TRUNK ROAD (KYLEAKIN, SKYE)

##### (40 MPH SPEED LIMIT) ORDER 199

THE SECRETARY OF STATE gives notice that he proposes to make the above Order to introduce a 40mph Speed Limit on the A87 Trunk Road at Kyleakin from the roundabout at its junction with the A850 in a south-westerly direction to a point 104 metres or thereby south-west of the north-east boundary of the property known as Crofters Kitchen, a distance of 327 metres or thereby.

Full details of the proposal are contained in the Order, which together with a plan showing the length of road involved and a statement of the Secretary of State's reasons for proposing to make the Order may be examined free of charge during business hours from 28th February 1997 to 28th March 1997 at:-
