Correction

COMPANY DIRECTORS DISQUALIFICATION ACT 1986

IN a Petition presented to the Court of Session in terms of section 6 of the above Act at the instance of Her Majesty's Secretary of State for Trade and Industry in respect of Stewart Gordon MacDuff the Court has, on 5th November 1997 ordered, *inter alia*, the following:-

"The Lord Ordinary having heard Counsel and having considered the Petition and proceedings Answers having been withdrawn disqualifies the Respondent Stewart Gordon MacDuff without leave of the Court for being a Director of a company, a Liquidator or Administrator of a company, a Receiver or Manager of a company's property or in any way whether directly or indirectly being concerned for taking part in the promotion, formation or management of a company for a period of 3 years from this date; directs that the making of this order to be registered by the Secretary of State for Trade and Industry and appoints intimation hereof to be made once by advertising in *The Edinburgh Gazette*; finds the Respondent liable to the Petitioner in the expenses of the Petition and remits an account thereof to the Auditor of Court to tax.
