NOTICE is hereby given that Dumfries and Galloway Council have made the above named Order under the Road Traffic Regulation Act 1984.

1. The general effect of the Order will be to impose 'no waiting at any time' restrictions on a specified length of B7079 Creebridge, Minnigaff. The Order shall commence on 8th December 1997.
