#### COMPANY DIRECTORS DISQUALIFICATION ACT 1986

IN a Petition presented to the Court of Session in terms of section 6 of the above Act at the instance of Her Majesty's Secretary of State for Trade and Industry in respect of Alexander Williamson, residing at 81A Loughborough Road, Kirkcaldy, Fife, ("the Respondent") Lord Penrose has, on 26th November 1997 disqualified the Respondent without leave of the Court, from being director of a company, a liquidator or administrator of a company, a receiver or manager of a company's property, or in any way, whether directly or indirectly, being concerned or taking part in the promotion, formulation or management of a company for a period of Four Years from that date and directs the making of this order to be registered by the Secretary of State for Trade and Industry and appoints intimation hereof to be made once by advertisement in *The Edinburgh Gazette*. Further having considered the Respondent's Note grants leave in terms of section 17 of the Act for the Respondent to remain as a director of and concerned in the management of Elmblock Limited, a company incorporated under the Companies Acts with a registered number SC152891 and having its registered office at 197 High Street, Kirkcaldy, Fife subject to Elmblock Limited continuing to comply with the mandate and the Respondent continuing to comply with the undertaking not to operate a Directors Loan Account for a period of four years from 26th November 1997. Lord Penrose also found the respondent liable to the petitioners in the expenses of the petition and the procedure following thereon and remits the account thereof, when lodged, to the Auditor of Court to tax.

The Lord Ordinary decerns against the respondent for payment to the petitioners of the expenses as the same shall be taxed by the Auditor of Court.
