AMENDMENTS TO THE TELECOMMUNICATIONS ACT 1984
AND WIRELESS TELEGRAPHY ACT 1949

THE above Act have been amended by Statutory Instrument 1997 No 2930, The Telecommunications (Licensing) Regulations 1997.

The changes are required to implement European Directive 97/13/EC of the European Parliament and of the Council on a common framework for general authorisations and individual licences in the field of telecommunications, (which was published in the Official Journal of the European Communities number L117 on 07.05.97) into United Kingdom legislation.

The Statutory Instrument was laid before Parliament on 10th December 1997 and enters into force on 31st December 1997.

Notice of intention to confirm a Provisional Order regarding the use of prepayment gas meters

The Director General of Gas Supply has given the notice set out below to British Gas Trading Ltd

THE GAS ACT 1986
Sections 29(1) and (4)

NOTICE

TO: BRITISH GAS TRADING LIMITED (BGT)

having its registered office at 50 Windsor Road, Slough, Berkshire SL1 2HA and the holder of a licence treated as granted under sections 7A(1)(a) and (b) of the Gas Act 1986 (the Act).

WHEREAS:

On 15th December 1997 the Director General of Gas Supply (the Director) issued a provisional order under section 28(2) of the Act in the terms set out in Annex 1 to this notice (the provisional order).

Now the Director hereby gives notice as follows.

1. The Director proposes to confirm the provisional order with modifications in the terms set out in Annex 2 to this notice (the modified order).
2. The effect of the modified order is to require BGT to continue to make available to those of its domestic customers who use, or may use, the domestic gas meter which has a pre-payment facility and which is known as, and is hereinafter referred to as, the Quantum Meter, those features of the Quantum Meter which allow for-

- (a) budgeting for payment for gas;
- (c) rationing the use of gas; or
- (c) the provision of emergency credit,

unless and to the extent that the Director consents to those features not being made available.

3. The relevant conditions for the purposes of the Notice and the Proposed Order are Standard Conditions 15 and 19 of the licence ("the Licence") treated as granted to BGT under sections 7A(1)(a) and (b) of the Act.
4. The acts or omissions which in the opinion of the Director would constitute a contravention of the relevant condition are-

(a) in respect of Standard Condition 15 of the Licence, the making, without the approval of the Director, of a material change in the arrangements made under that condition, for the purpose of satisfying Standard Condition 19 of the licence, by withdrawing the nature of the Quantum meter referred to in paragraph 2 above, which features are part of the said arrangements by virtue of the Quantum meter with those features being the prepayment meter in the contemplation of both BGT and of the Director, and being the prepayment meter usually installed, at the time when the said arrangements were established; and

(b) in respect of Standard Condition 19 of the Licence, the failure to make arrangements under Standard Condition 15 of the Licence in relation to any of the Licensee's domestic customers who, through misfortune or inability to budget to meet bills for gas supplied on credit terms, incurs obligations to pay for gas so supplied which he finds difficulty in discharging, which provide for offering a prepayment meter, within the meaning of that term for the purpose of Standard Condition 19, which, by virtue of the usage of Quantum meters with the features referred to in paragraph 2 above, means a prepayment meter with those features.

5. The other facts which, in the opinion of the Director, justify the confirmation of the modified order are-

(a) that the budgeting and rationing features of Quantum meters referred to in paragraph 2 above are important to many domestic customers who have difficulty in discharging obligations to pay for gas supplied to them and are used by such customers;

(b) the emergency credit feature of Quantum meters referred to in paragraph 2 above is important to the operation of Quantum meters; and

(c) that the Director considers it likely that, if the modified order is not confirmed, the licensee will cease to make available some or all of the features of Quantum meters referred to in paragraph 2 above to some or all of its domestic customers who take their gas supply through Quantum meters.
