STATEMENT OF STEPS TAKEN TO ACHIEVE THE ECONOMIC OBJECTIVE

For the Formula Year commencing on 1st April 1997

THIS statement is made in compliance with clause 7. (2) of condition 3 of the Special Conditions of British Gas Trading's Licence as a Gas Supplier, which requires the Licensee to publish a document stating the steps taken by the Licensee to achieve the Economic Objective in relation to the total costs of Regulated Gas.

In respect of the Formula Year, as defined in Clause 1. (1) of British Gas Trading's Licence Conditions:

"Economic Objective" means the objective, which is to be treated as having taken effect on 1st October 1996, of managing the purchases of Regulated Gas (including whether by entering into, varying or terminating contracts, or exercising the rights to call for delivery of Regulated Gas under contracts) in the most economically advantageous way for the Licensee and any Related Person of the

"Regulated Gas" means gas (except gas for consumption in premises owned or occupied by the Licensee or a Related Person of the Licensee) purchased -

- a) by the Licensee under any contract entered into before 1st October 1996;
- b) by a Related Person of the Licensee under any contract entered into before 1st October 1996 except where the Director General of Gas Supply has determined (after consulting the Licensee and that person) prior to the inclusion of this Condition in the licence that as purchased under such contract should not be treated as Regulated Gas; or
- c) by the Licensee or a Related Person of the Licensee under any other contract which, after taking account of any transaction or series of transactions of which that contract forms a part, can properly be regarded as a contract for the purchase of gas -
 - for enabling activities within the Gas Shipping and Supply Business to be carried on (except any contract for the acquisition of gas in the operation of a flexibility market within the meaning of condition 3(1)(a) of the standard Conditions of Gas Shippers' Licenses);
 - ii) for delivery over a period exceeding six months or, in the case of a contract for the purchase of gas by a Related Person of the Licensee, exceeding twelve months; or
 - iii) for enabling a particular contract for the sale of gas during a period exceeding six months or, in the case of a contract for the sale of gas by a Related Person of the Licensee, exceeding twelve months, to be discharged.

"Related Person" means a person who is -

- a) a related person within the meaning of the Standard Conditions;
- b) carrying on the activity of producing or purchasing gas which is
 - i) landed in Great Britain;
 - ii) not consumed in premises owned or occupied by that person; and
- c) not an Excluded Person

In the Formula Year 1997/8, Related Persons to the Licensee were Accord Energy Limited and Hydrocarbon Resources Limited.

1. Total Gas Costs

The total amount paid or payable in respect of Total Gas Costs in the Formula Year consistent with the Economic Objective is £3,847.5 million. This is the aggregate of the amounts relating to the following parts of the definition of Total Gas Costs as given in Clause 1. (1) of condition 3 of British Gas Trading's Special Conditions of its Supplier's Licence:

- a) Payments by the Licensee or Related Persons to vendors of Regulated Gas who are not Related Persons
 - (i) payments for Regulated Gas by the Licensee payments for Regulated Gas by Related Persons

- (ii) capacity charges paid by the Licensee capacity charges paid by Related Persons
- b) Prepayments for gas delivered in the Formula Year
 - (i) initial payments
 - (ii) interest on the initial payment, accrued since 1st April 1997
- c) Processing costs to meet the requirements of any public gas transporter
 - (i) payable to non-Related Persons
 - (ii) payable to Related Persons
- d) Payments by the Licensee for the conveyance of Regulated Gas
 - (i) to shippers who are non-Related Persons
 - (ii) to shippers who are Related Persons
- e) Payments for Own Gas based on the Market Value as ascertained by the Oil Taxation Office (OTO) of the Inland Revenue
- f) Gas Levy payable to the Secretary of State in the Formula Year
- g) Any other appropriate amounts

Renegotiation costs Other relevant costs

2. British Gas Trading's reasons for forming the opinion that Total Gas Costs are consistent with the Economic Objective

This section explains the main components of each category of costs and summarises the approach and types of actions taken by the Licensee to ensure that Total Gas Costs are consistent with the Economic Objective. The Total Gas Costs relate to total volumes of Regulated Gas purchased in the Formula Year of 17,953 million therms.

In considering the management of the gas portfolio it must be recognised that neither the sales of Regulated Gas nor the total gas sales of the Licensee or Related Persons can be known in advance. Furthermore, Regulated Gas comprises a wide range of different sources of gas with different contractual characteristics and counterparties.

The Licensee has continuously sought to improve its gas cost base through the ongoing commercial management of the gas purchasing portfolio. Where counterparties have been willing to enter into variations which made sound commercial sense then these deals have been pursued.

Annual Take targets have also been set and frequently reviewed to ensure that the scheduling of supplies is the most economically advantageous which can reasonably be expected to be achieved. In practice this judgement has involved the general principle of aiming to minimise the payments for gas over time, whilst taking into account the risks and constraints associated with a wide variety of contractual, operational and seasonal factors.

a) Payments by the Licensee or Related Persons to vendors of Regulated Gas who are not Related Persons

These payments are by far the largest proportion of the Total Gas costs and arise primarily from the Licensee's pre October 1996 gas purchase contracts.

Nominations for the delivery of gas from these contracts were scheduled in the most economically advantageous way by considering the targets required for each supply year (1st October to 30th September) within the formula year and then developing the optimal within-supply year scheduling, taking into account, amongst other things, the contracted 'Take or Pay' requirement, the flexibility of deliveries available to the Licensee, the prevailing contract prices, and transportation issues. This was an ongoing and a continuous process with changes to supply schedules being made in response to changes in demand (for example as a result of the weather), supply availability, or market conditions.

In addition to the special cases of Contract Renegotiation discussed under (g), contract management has included the agreeing of a wide variety of contractual variations ranging from minor contract changes in which the Licensee has improved the commercial value of purchase contracts through changes to contract terms through to major disputes with sellers in which the Licensee has sought to reduce the size of payments made to sellers.

Opportunities have also been pursued via Accord Energy Limited to obtain short term purchases from the Spot Market where this has been the most economic way to meet the Licensee's requirements for gas in the Gas Shipping and Supply Business.

The Capacity charge is a mechanistically calculated fixed sum payable to certain offshore suppliers for the service of delivering gas to Bacton at high rates in the winter. This payment is independent of the volume of gas delivered to the Licensee.

Payments made under the flexibility mechanism are not included in the Total Gas Cost Notice, but the net quantity of gas purchased in the Formula Year is included in the total volume of Regulated Gas stated above. Under the Special Licence Condition the Net Flexibility Cost, (whether positive or negative) is added to the Allowable Total.

Transportation Cost. During this period, the Licensee was operating under a flexibility mechanism participation policy statement volunteered to Ofgas.

b) Prepayments for gas delivered in the Formula Year

These amounts relate wholly to the recovery of 'Take or Pay' credits from the Licensee's long term gas purchase contracts. The 'Take or Pay' contracts were managed during the Formula Year to ensure that credits arising from the prepayment of gas were not lost (irrecoverable 'Take or Pay'). In the Formula Year the Licensee was able to recover approximately 1.5 billion therms of 'Take or Pay' credits.

c) Processing costs to meet the requirements of any public gas transporter

This charge relates to the compression of gas at the Total Oil Marine subterminal at St Fergus, where gas is delivered at pressures lower than those acceptable to Transco for delivery into its pipeline system.

d) Payments by the Licensee for the conveyance of Regulated Gas

This charge relates to arrangements made with a third party gas shipper for conveyance of Regulated Gas through a pipeline system not operated by BG plc.

e) Payments for Own Gas based on the Market Value as ascertained by the Oil Taxation Office (OTO) of the Inland Revenue

This amount relates to gas delivered to the Licensee from the North and South Morecambe gas fields which are wholly owned by the Licensee's subsidiary Hydrocarbon Resources Limited (HRL).

For both North Morecambe gas and for South Morecambe gas, the market values as defined in the Oil Taxation Act 1975 are the prices determined from price formulae specified in elections made to and accepted by the Inland Revenue. The North Morecambe election was made and accepted prior to the commencement of the Formula Year and could not be revoked by the Licensee or HRL during the Formula Year. The price formula is the contract price in the Gas Sales Agreement between HRL and the Licensee.

The South Morecambe election was also made and accepted before the Formula Year but, Centrica was able to take steps to reduce its tax liability and the payments made by the Licensee for Own Gas by serving a tax price revocation notice. The OTO accepted the revocation and agreed a reduction to a price which would 'float' at a level related to the forward spot market. This new price structure came in to force from 1st January 1998.

f) Gas levy payable to the Secretary of State in the Formula Year

For a period commencing prior to the Formula Year, Centrica lobbied the Government for the removal of the Gas Levy. In the July 1997 budget, the Chancellor of the Exchequer announced that the Gas Levy would be phased out from April 1998. Centrica then pressed the Government further to reduce the Gas Levy as early as possible. In the November 1997 budget, the Chancellor stated that the Gas Levy would be reduced from 4p/therm to 3p/therm from the beginning of January 1998. This has lead to a reduction in the amount of Gas Levy to be paid in the Formula Year.

g) Any other appropriate amounts

The first deals on the renegotiation of the long term contracts were announced in December 1996 and since then a number of further deals have been completed. There are significant benefits which arise in the Formula Year.

The costs of these renegotiations have been allocated on a year by year basis following the methodology set out by Ofgas in Appendix 2 of the document "1997 Price Control Review Supply at or below 2,500 therms a year - British Gas Trading" issued by Ofgas in May 1997 and discussed subsequently with Ofgas in September 1998.

The other relevant costs included are for the costs of the independent Assessor and for litigation costs and counsel fees incurred during the Formula Year in managing specific disputes in relation to gas purchase contracts.

Given the wide range of actions undertaken by the Licensee and Related Persons in each of these areas the Licensee is of the opinion that it has done all that could reasonably be achieved to reduce its purchase costs in line with the Economic Objective.

REGULATION 5

PROPOSED CONSTRUCTION OF ELECTRICITY TRANSMISSION LINE BETWEEN KINLOCHLEVEN AND LUNDAVRA, LOCHABER.

IN the pursuance of the above Regulations, notice is hereby given that Scottish Hydro Electric plc, Registered Office, 10 Dunkeld Road, Perth PH1 5WA has submitted to the Secretary of State for Scotland:-

(a) An application for consent under Section 37 of the Electricity Act 1989 to the placing of a 132kv wood pole line between Kinlochleven and the existing tower line at Lundavra, South of Fort William, within the Lochaber Local Plan Area. (b) An Environmental Information and Appraisal Report.

This new line will replace the existing 33kv wood pole line.
