The West Lothian Council on 16th July 1999 made the above mentioned Order which will come into effect on 3rd August 1999. The effect of the Order is to impose limits on vehicular speed as stated in detail in Notice 1501/65 in *The Edinburgh Gazette* number 24563 dated 5th March 1999 and the *West Lothian Courier* of 4th March 1999.

A copy of the Order together with explanatory map, a copy of the press notice and a statement of the Council's reasons for making the Order, may be examined between the hours of 9.00am and 4.30 pm Mondays to Fridays during the period 22nd July 1999 to 27th August 1999 at West Lothian Council Headquarters, West Lothian House, Almondvale Boulevard, Livingston.

Any person wishing to question the validity of the Order or any provision made in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, as amended, or on the grounds that any requirement of that Act or any relevant regulation has not been complied with in relation to the Order, may within six weeks from the above date of making, apply to the Court of Session for this purpose.
