The following Address has been presented to his Royal Highness the Prince Regent; which Address his Royal Highness was pleased to receive very graciously:

To his Royal Highness the PRINCE REGENT. WE, the Bailies, Councillors, and Burgesses of Stromness, convened in a general meeting, beg leave to express our united and unfeigned sentiments of loyalty to your Royal Highness, and of attachment to his Majesty's government, the high functions of which have been so splendidly exercised under your Royal Highness's auspices.

We feel ourselves peculiarly called upon at this season to express these sentiments, because we are this day assembled, for the first time, in a legally constituted body under the sanction of a royal charter, erecting Stromness into a burgh of barony; and we deem it incumbent upon us, as the first act of our corporate existence, to lay this testimony of our gra-

titude and respect before your Royal Highness. We unite with all the good and respectable part of his Majesty's subjects, in deploring the madness of a misguided rabble, who lately offered an outrageous insult to the sovereign authority of the empire, in your Royal Highness's person, while employed in one of the highest duties of a British monarch. When we contemplate the fundamental doctrines of the British constitution, we are not at liberty to regard that outrage merely with the horror which every act of violence naturally inspires, but viewing your Royal Highness as at present the depositary of your venerated father's authority, we consider that insult as a seditious attack upon his crown, as a viola-tion of the constitution which encircles him with security and honour, and a melancholy proof, that a pestilent wickedness exists among some of our fellow-subjects, which, if unresisted and unsubdued, might, ere long, shake to pieces the whole frame of society, and subvert our laws, our liberties, and our national

Although situated in these poor and distant it beyond the sphere of our duties, in times like the present, to avow the political principles which we cherish.

We lament the delusions which bewilder a set of wrong-headed men, who ignorantly clamout for

changes which are objectionable, not because they are innovations, but because they are radically and extravagantly mischievous in their tendency.

We prize and enjoy the blessings of substantial freedom, for while British subjects lead quiet and peaceable lives, none dare make them afraid. We re-Joice in the example of self-denial, economy, and re-trenchment which your Royal Highness has recently set; and consider it a pledge, that his Majesty's government will, as much as possible, lessen the heavy burdens which the nation has long borne. We confide in the wisdom and integrity of Parliament, and that they will adopt every practicable reform.

Finally, we pray that Almighty God may shield your Royal Highness from all dangers, and that the illustrious house of Brunswick may long be upheld by the power and the principles which seated its princes on the throne of these realms.
