DESIGNATION OF NEW CONSERVATION AREAS AND ALTERATIONS TO BOUNDARIES OF EXISTING CONSERVATION AREAS

Notice is hereby given in terms of section 61 of the above Act that East Lothian Council as Local Planning Authority has made the following changes to its Conservation Areas:

- East Lothian Council has designated the following three *New Conservation Areas*:
 - Glenkinchie* - the Conservation Area includes the Distillery buildings and nos. 1 -19 Glenkinchie houses.
 - Spott* - the Conservation Area includes properties known as 1-34 Spott village extending from Canongate to The Square
 - West Barns* - the Conservation Area includes the policies of Bielside House and its lodges; Bielside Gardens, Duke Street, The Trows, Seafield House; Bridge Cottages; Red Tiles, Ardshiel, Mayholm, West Barns House, West Barns Hall; Implement Road; Lothian Cottage, the former Co-op building; The Green; Strathearn House; Seafield Cottages; Seafield and Brewery Cottage.
- East Lothian Council has made the following *Alterations* to the boundaries of the following Conservation Areas to include the following addresses in each:
 - Aberlady Conservation Area* - extended to include the primary school and playing fields and all properties in the Pleasance, Elcho Terrace and Kirk Road.
 - Athelstaneford Conservation Area* - extended to include land to the south of all existing properties in the village. This area does not include any additional properties.
 - Dunbar Conservation Area* - extended to the north west to include all properties on Bayswell Park, Bayswell Road, (including Roseberry Place, Stanley Place and Mayville Park), Marine Road, Gardener Street, Letham Place North Road (Forth View, Mayfield, Nelson Villa, Southcot, Bruceville, Echo Bank, Roslyn, Dalfruin, Lochinver) and Lauderdale Park. Extended to the south east to include the site of the former Roxburghe Hotel including Roxburghe Court, Roxburghe Terrace, all properties on Queen's Road including the former Bellevue Hotel and Newhouse Terrace. The following properties are now *Excluded* from Dunbar Conservation Area - nos. 2 - 40 and 1-21 Parsonspool.
 - East Linton* - extended to include the houses and their curtilages forming nos. 1 - 9 Preston Road, Lauder Place and the eastern section of Station Road including the Medical Centre, Station House, The Harvester's Old Toll House, Mansford, Riverside House, Harvester's Cottage, Torness Motors and 3 Station Road.
 - Gullane* - extended to include the houses known as Muirdale, Seagate, Bentfield and the Rectory comprising 1 - 4 Marine Terrace.
 - Inveresk* - extended to include all properties to the south of the railway line at Carberry Road and Close.
 - North Berwick* - extended to include nos. 1 - 6 Abbotsford Park, Carlekemp, Milton Lodge, Strathearn Road (Little Edradour, Edradour, West Edradour, Crichton Cottage, Arkle Cottage, Coach House, Meadowside Cottage, Meadowside and Amisford only), all properties on Fidra Road, all properties on Hamilton Road, all properties on Cromwell Road, all properties on York Road, all properties on Links Road, West Bay Court, all properties on West Bay Road, 1 Station Road, all properties on Station Hill, nos. 1 - 61 and 2 - 38 Dirleton Avenue, nos. 25 - 55 Westgate, 1 - 2 Abbey Crescent, 3 - 5 Abbey Road, 1 Bank

Street, Kingshill and Kerilla Bank Street, all properties on Marmion Road, nos. 17 - 31 St Andrews Street, 26 & 37/39 Clifford Road, Brentwood Court, nos. 7-11 Nungate Road, all properties in St Margaret's Road and 6 Law Road.

Tranent - extended to include all properties on the east side of Winton Place from the car park on the corner of Winton Place and Lindores Drive and properties on the north side of High Street from Winton Place to 128 High Street inclusive and all properties on the south side of High Street from no. 43 to the Ormiston Road junction and including nos. 1 - 5 Ormiston Road.

The principal effects of these designations is that the above areas are now subject to greater controls to protect their character. In particular, buildings within the Conservation Areas may require Conservation Area Consent for their demolition; trees are protected by law and the written consent of East Lothian Council must be obtained before lopping, pruning, felling or uprooting any tree and the repainting, stone cleaning or recladding of external walls will require planning permission.

Details of all these changes and the adopted policies of East Lothian Council that affect Conservation Areas are contained within the adopted East Lothian Local Plan. These, along with maps showing the above affected areas, can be viewed during normal opening hours at East Lothian Council at John Muir House, Haddington, East Lothian; at the Brunton Hall, Musselburgh, East Lothian and at any East Lothian library.

These Regulations may be cited as The Specified Risk Material (Amendment) (England) Regulations 2001, and came into force on 1st April 2001.

These Regulations, which extends to England only are made by the Minister of Agriculture, Fisheries and Food to make two changes to the processing requirements at rendering plants in England approved by the Minister of Agriculture, Fisheries and Food under the Specified Risk Material Regulations 1997.

The first change gives effect to articles 3.1 and 7(b) of, and paragraph 3(b)(ii) of Annex 1 to, Commission Decision 2000/418/EC (OJ No. L 158, 30.6.2000, p. 76) regulating the use of material presenting risks as regards transmissible spongiform encephalopathies and amending Decision 94/474/EC. Specified risk material which is to be buried at licensed landfill sites must first have been processed at an approved rendering plant in accordance with method 4 prescribed in Part II of Schedule I to the Specified Risk Material Regulations 1997.

The second change is related to the requirements of paragraph 3(b)(ii) of Annex I to the Commission Decision. It will allow mixing of specified risk material with other material at approved rendering plants providing all the material is dealt with a specified risk material. Specified risk material kept, stored, handled and rendered at an approved rendering plant, whether processed in accordance with that method 4, or in accordance with one of the other methods prescribed in Part II of Schedule 1 to the Specified Risk Material Regulations 1997, may now be kept, stored, handled and rendered with other material at the approved rendering plant providing all the material is kept, stored, handled and rendered as specified risk material and records are kept for two years of the exact quantities of all the specified risk material and other material concerned.

A Regulatory Impact Assessment has been prepared and placed in the library of each House of Parliament. Copies can be obtained from the BSE Division of the Ministry of Agriculture, Fisheries and Food, Page Street, London.

This Order (article 2 and the Schedule) amends Schedule 1 to the 1978 Order by adding to that schedule several entries for other approved disinfectants.

These Regulations may be cited as The Foot-and-Mouth Disease (Export of Vehicles) (Disinfection of Tyres) Regulations 2001 and came into force on 10th March 2001.

These Regulations, which extend to the United Kingdom, implement Article 10(2) of Commission Decision 2001/190/EC amending Commission Decision 2001/172/EC concerning certain protection measures with regard to foot-and-mouth disease in the United Kingdom (OJ No. L67, 9.3.2001, p.88).

The Regulations impose, for the purpose of preventing the spread of foot-and-mouth disease, an obligation on the managing body of a port or, where there is an operator of a seaport terminal that operator, to ensure that no road vehicle is transported to a destination outside the British Islands through that port or terminal unless the tyres of that vehicle have been treated with an approved disinfectant (regulation 3).

A power is conferred on inspectors to enter land or premises and to carry out examinations for the purpose of ascertaining whether there has been any contravention of the Regulations (regulation 4).

Obstruction is an offence (regulation 5) and company directors and others can be punished for an offence by a body corporate (regulation 6).

Breach of the Regulations is punishable on summary conviction by a fine of up to £5,000 or by imprisonment for a term not exceeding three months or to both (regulation 7).

The Regulations are enforced in England, Wales and Scotland by the Minister or the local authority and in Northern Ireland by the Department of Agriculture and Rural Development (regulation 8). 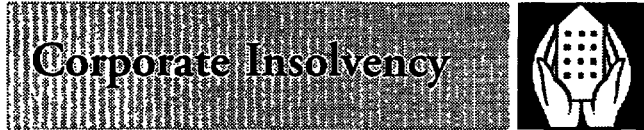
