Briefly, this has the effect of restricting the rights of non-acceding Creditors to do diligence (ie to enforce court decrees for unpaid debts) against the Debtor and confers certain protection upon the Trust Deed from being superseded by the sequestration of the Debtor's estate.

TRANSFER OF GENERAL INSURANCE BUSINESS

1. NOTICE IS HEREBY GIVEN that Zurich Versicherung Aktiengesellschaft (Deutschland) ("ZVAG") will be applying to BaFin (the German insurance supervisory authority) for their approval, pursuant to article 12 of the Third Non-Life Insurance Directive (Directive 92/49/EEC), to transfer all of ZVAG's rights and obligations under policies written by ZVAG in the United Kingdom to a German Branch of Zurich Insurance plc. The transfer shall be accomplished by way of a cross border merger of ZVAG into Zurich Insurance plc according to the respective German and Irish legislation implementing the Directive 2005/56/EC of the European Parliament and Council of 26 October 2005 on cross-border mergers.

2. Zurich Insurance plc is an Irish company headquartered in Dublin which is regulated by the Irish Financial Regulator. Both ZVAG and Zurich Insurance plc are members of Zurich group of companies. Accordingly, the transfer will not result in any change to the terms and conditions of any insurance policies except that policies will, following the transfer, be with the German branch of Zurich Insurance plc rather than ZVAG.

The Financial Services Authority will not consent to the transfer until after considering any representations made to them before this date.
