in commemoration of the distinguished conduct of the late 2d Battalion of that Regiment in the Pyrenecs, in the month of July 1813; at Nivelle, on 10th November 1813; in the passage of the Nive, on 9th, 10th, and 11th December 1813; and at Orthes, on 27th February 1814.
