There is a considerable quantity of fine old and of thriving young wood on the estate, which lies compactly together, has almost throughout a southern aspect, and presents several fine situations for building. It abounds in game, and the river Ae, which is an excellent trouting stream, is partly its bound-

ary on the west and south.
