These lands were formerly let much higher then they are now valued at, but from the remoteness of the situation and the late depression in land produce, the witnesses examined in the sale have deponed that from 25 to 30 per cent. ought to be deducted from the former rents, which has been dore accordingly, and a purchaser will thus receive a return for the investment of his capital, rarely to be met with in these timer

The lands are held partly of the crown and partly of sub-jects superior, and no value has been put upon the crown superiorities. The teinds of all the three parishes are valued and exhausted by the allocation of stipend, and the patronage of the churches is in the crown.
