WESTMINSTER, June 21, 1827.

HIS day, the Lords being met, a message was sent to the Honourable House of Commons by the Gentleman Usher of the Black Rod, acquainting them, that The Lords, authorized by virtue of a Commission under the Great Seal, signed by His Majesty, for declaring His Royal Assent to several Acts agreed upon by both Houses, do desire the immediate attendance of the Honourable House in the House of Peers to hear the Commission read; and the Commons being come thither, the said Commission, empowering the Lord Arch-bishop of Canterbury, the Lord High Chancellor of Great Britain, and several other Lords therein named, to declare and notify the Royal Assent to the said acts, was read accordingly, and the Royal Assent given to

An Act for raising the sum of thirteen millions eight hundred thousand pounds by Exchequer Bills, for the ser-vice of the year one thousand eight hundred and twenty-

An Act for granting and applying certain sums of money for the service of the year one thousand eight hundred and twenty-seven.

An Act to continue, until the tenth day of October one thousand eight hundred and thirty, an Act relating to duties of Excise on crown, flint, and phial glass; and to alter certain laws of Excise relating to flint glass.

An Act to make further regulations for preventing corrupt practices at elections of Members to serve in Parlia-

ment, and for diminishing the expence of such elections.

An Act to repeal such parts of two Acts of King William and Queen Mary, and of King George the Second, as relate

to the settling the rates of the carriage of goods.

An Act for the further improvement and maintenance of the harbour of Dunbar, and other public works within the burgh of Dunbar, and for the better supplying the said burgh with water.

An Act for recovering, draining, and preserving certain lands in the parishes of Kinross, Orwell, and Portmoak, in the county of Kinross, and in the parishes of Ballingry, Auchterderran, and Kinglassie, in the county of Fife; and for the better supplying with water the mills, manufactories, bleachfields, and other works situated on or near the River of Leven, in the said county of Fife.

An Act for repairing and keeping in repair the turnpike roads in the county of Ayr; for making and maintaining certain new roads; for rendering turnpike certain parish

roads; and for regulating the statute labour in the said


