St. James's Palace, September 17, 1827.

THE King has been pleased to appoint Robert Cotton St. John, Lord Clinton, to be one of the Lords of His Majesty's Bedchamber, in the room of Lord Graves, resigned.

WHITEHALL, September 17, 1827.

The King has been pleased to direct letters patent to be passed under the Great Seal, granting the dignity of a Marquess of the United Kingdom of Great Britain and Ireland unto the Right Honourable William Harry Earl of Darlington, and the heirs-male of his body lawfully begotten, by the name, stile, and title of Marquess of Cleveland.

The King has been pleased to order a congé d'elire to pass the Great Seal, empowering the Dean and Chapter of the Cathedral Church of Carlisle to elect a Bishop of that See, the same being void by the death of the Right Reverend Father in God Doctor Samuel Goodenough, late Bishop thereof; and His Majesty has also been pleased to recommend to the said Dean and Chapter the Right Reverend Father in God the Honourable Doctor Hugh Percy, now Bishop of Rochester, to be by them elected Bishop of the said See of Carlisle.
