WINDSOR-CASTLE, November 24, 1828.

HIS day the Chevalier de Zea Bermudez, Envoy Extraordinary and Minister Plenipotentiary from His Catholic Majesty; and James Barbour, Esq. Envoy Extraordinary and Minister Plenipotentiary from the United States of America, had their first private audiences of His Majesty, to deliver their credentials; to which audiences they were respectively introduced by the Earl of Aberden, His Majesty's Principal Secretary of State for Foreign Affairs, and conducted by Sir Robert Chester, Knt. Master of the Ceremonies.

The King was this day pleased to confer the honour of Knighthood upon the Honourable Robert Cavendish Spencer, a Captain in the Royal Navy, as Knight Commander of the Royal Hanoverian Guelphic Order.

The King has been graciously pleased to nominate and appoint John Henry Lance, Esq. to be His Majesty's Commissary Judge, in the room of Christopher Edward Le Froy, Esq.; and Campbell James Dalrymple, Esq. to be His Majesty's Commissioner of Arbitration, in room of John Henry Lance, Esq. to the Mixed British and Netherland Commission established at Surinam, under the Treaty concluded on the 4th of May 1818, between His Majesty and the King of the Netherlands, for the prevention of illegal traffic in Slaves, and pursuant to the Act of Parliament passed for carrying that Treaty into effect.

IN the Process of Ranking and Sale of the Estate of Glenorchard and others, in Stirlingshire, depending before the Court of Session, (First Division, Mr. William Pringle, Clerk.) at the instance of Alexander Stevenson, Writer to the Signet, as Trustee for John M'Naughton Menzies, Brother of the deceased Stuart Menzies, Esquire, of Culdares, against the said John Fullarton and his Creditors, Lord Corehouse, for Lord Eldin, Ordinary, on the 27th November 1828, pronounced the following Interlocutor.—
