Extract of a Letter from Rear-Admiral BLIGH to EVAN NEPEAN, Esq. dated on board his Majesty's ship Bruns-wick, Mole St Nichola, St Domingo, October 31.

SMALL French schooner privateer, mounting one gun and three swivels, and twenty-five men, called Le Capitaine Generoux, was brought in here the 18th instant, captured by his Majesty's ship Adventure and armed schooner Le Dauphin Royal, belonging to St Domingo. She had failed from Aux Cayes two days, and had taken nothing.
