ST. JAMES'S-PALACE, August 4, 1830.

THIS day the Count Saint Martin D'Aglie, Envoy Extraordinary and Minister Plenipotentiary from the King of Sardinia, and the Baron de Cetto, Envoy Extraordinary and Minister Plenipotentiary from the King of Bavaria, had their first private audiences respectively of the King to deliver their credentials, and to deliver letters of condolence upon the death of the late King, and of congratulation to His Majesty upon His accession to the throne; also the Count Bjornstjerna, on a special mission from the King of Sweden, had his first private audience of the King to deliver a letter of condolence upon the death of the late King, and a letter of congratulation to His Majesty upon his accession to the throne; to which audiences they were severally introduced by the Earl of Aberdeen, His Majesty's Principal Secretary of State for Foreign Affairs, and conducted by Sir Robert Chester, Knt. This day the Prince Esterhazy, Ambassador Extraordinary from the Emperor of Austria; the Count Saint Martin D'Aglie, Envoy Extraordinary and Minister Plenipotentiary from the King of Sardinia; the Count Moltke, Envoy Extraordinary and Minister Plenipotentiary from the King of Denmark; the Baron de Cetto, Envoy Extraordinary and Minister Plenipotentiary from the King of Bavaria; the Count Bjornstjerna, on a special mission from the King of Sweden to deliver to His Majesty a letter of condolence upon the death of the late King, and a letter of congratulation upon His Majesty's accession to the throne; and the Chevalier de Zea Bermudez, Envoy Extraordinary and Minister Plenipotentiary from the King of Spain, had their first private audiences of Her Majesty the Queen; to which they were respectively introduced by Earl Howe, Her Majesty's Lord Chamberlain, and conducted by Sir Robert Chester, Knt. Master of the Ceremonies.

His Majesty was this day pleased to invest Francis Earl of Moray with the ensigns of the Most Ancient and Most Noble Order of the Thistle.

His Majesty having signed the several instruments for

that purpose, which were previously to the ceremony pre-

sented to the Sovereign by Robert Quarme, Esq. Gentleman Usher of the Green Rod, in the absence of the Secretary.

The Earl of Moray was called into the Royal Presence, being preceded by His Royal Highness the Duke of Sussex, and supported by the Earls of Cathcart and Aberdeen, the two Senior Knights present.

Upon entering into the Royal Presence, with the usual reverences, the Earl of Moray was presented by the said two Knights, and, kneeling down, was knighted by the King with the sword of state; his Lordship, having kissed His Majesty's hand, rose up, when the Gentleman Usher of the Green Rod administered the oath to his Lordship; then Green Rod, kneeling, presented the ensigns of the Order, upon a crimson velvet cushion, to the King, who put the ribband over the Earl's left shoulder; and his Lordship, having again had the honour of kissing His Majesty's hand, withdrew, with the usual reverences, in the same manner in which he had entered.

The ceremony was performed in the King's Closet, be-fore the Levee, several of the Great Officers of State and of the Court being present.

This day, by command of His Majesty, Major-Generals Sir Charles Pratt and Sir William Williams, Knights Com-manders of the Most Honourable Military Order of the manders of the Most Honourable Military Order of the Bath, were introduced into the Royal Presence, preceded by Sir George Nayler (the Officer of Arms attendant upon the Knights Commanders), bearing upon a crimson velvet cushion the star appropriated to the second class of the Order. The Sovereign was then graciously pleased to invest the said Major-Generals respectively with the star of a Knight Commander; whereupon they had the honour to kiss the Sovereign's hand, and withdrew.
