

At the Court at St. James's, the 23d day of February 1831,

PRESENT.

The KING's Most Excellent Majesty in Council.

THIS day the Right Honourable Archibald John Earl of Rosebery, the Right Honourable John William Ponsonby (commonly called Viscount Duncannon), and the Right Honourable Michael Angelo Taylor, were, by His Majesty's command, sworn of His Majesty's Most Honourable Privy Council, and took their respective places at the Board accordingly.

ST. JAMES'S-PALACE, February 23, 1831.

Master of the Ceremonies.
