

ST. JAMES'S-PALACE, April 22, 1831.

St. James's-Palace to the House of Peers, where he arrived about three o'clock; and, having alighted from the state coach, was received at the portico by the Great Officers of State and others, and proceeded to the robing-room in the customary manner.

His Majesty was there robed, and the procession moved into the House in the usual order.

His Majesty being seated upon the Throne, the Great Officers of State and others standing on the right and left, Sir Thomas Tyrwhitt, Knt. Gentleman Usher of the Black Rod, was sent with a message from His Majesty to the House of Commons, commanding their attendance in the House of Peers. The Commons being come thither accordingly, His Majesty was pleased to deliver the following most gracious Speech to both Houses of Parliament.

My Lords, and Gentlemen,

I HAVE come to meet you for the purpose of proroguing this Parliament, with a view to its immediate dissolution.

I have been induced to resort to this measure for the purpose of ascertaining the sense of My People, in the way in which it can be most constitutionally and authentically expressed, on the expediency of making such changes in the Representation as circumstances may appear to require, and which, founded upon the acknowledged principles of the Constitution, may tend at once to uphold the just rights and prerogatives of the Crown, and to give security to the liberties of the People.

Gentlemen of the House of Commons,

I thank you for the provision you have made for the maintenance of the honour and dignity of the Crown, and I offer you my special acknowledgments for the arrangements you have made for the state and comfort of My Royal Consort; I have also to thank you for the supplies which you have furnished for the public service; I have observed with satisfaction your endeavours to introduce a strict economy into every branch of that service; and I trust that the early attention of a new Parliament, which I shall forthwith direct to be called, will be applied to the prosecution of that important object.

My Lords, and Gentlemen,

I am happy to inform you, that the friendly intercourse which subsists between Myself and Foreign Powers, affords the best hopes of the continuance of Peace, to the preservation of which My most anxious endeavours will be constantly directed.

My Lords, and Gentlemen,

In resolving to recur to the sense of My People, in the present circumstances of the Country, I have been influenced only by a paternal anxiety for the contentment and happiness of My Subjects, to promote which I rely with confidence on your continued and zealous assistance.

Then the Lord Chancellor, by His Majesty's command, prorogued the Parliament accordingly.

A PROCLAMATION,

For dissolving the present Parliament, and declaring the calling of another.

WILLIAM, R.

HEREAS We havethought fit, by and with the advice of Our Privy Council, to dissolve this present Parliament, which stands pro-rogued to Tuesday the tenth day of May next: We do for that end publish this Our Royal Proclamation, and do hereby dissolve the said Parliament accordingly; and the Lords Spiritual and Temporal, and the Knights, Citizens, and Burgesses, and the Commissioners for shires and burghs, of the House of Commons, are discharged from their meeting and attendance on the said Tuesday the tenth day of May next: And We, being desirous and resolved, as soon as may be, to meet Our peo-ple, and to have their advice in Parliament, do hereby make known to all Our loving subjects Our Royal will and pleasure to call a new Parliament: And do hereby further declare, that, with the advice of Our Privy Council, We have given order to Our Chancellor of that part of Our United Kingdom called Great Britain, and Our Chancellor of Ireland, that they do respectively, upon notice thereof, forthwith issue out writs in due form, and according to law, for calling a new Parliament: And We do hereby also, by this Our Royal Pro-clamation under Our Great Seal of Our United Kingdom, require writs forthwith to be issued accordingly by Our said Chancellors respectively, for causing the Lords Spiritual and Temporal and Commons, who are to serve in the said Parliament, to be duly returned to, and give their attendance

in Our said Parliament; which writs are to be returnable on Tuesday the fourteenth day of June next.

By the KING. A PROCLAMATION,

In order to the electing and summoning the Sixteen Peers of Scotland.

WILLIAM, R.

HEREAS We have in Our Council thought fit to declare Our pleasure, for summoning and holding a Parliament of Our United Kingdom of Great Britain and Ireland, on Tuesday the fourteenth day of June next, ensuing the date hereof; in order, therefore, to the electing and summoning the Sixteen Peers of Scotland, who are to sit in the House of Peers in the said Parliament, We do, by the advice of Our Privy Council, issue forth this Our Royal Proclamation, strictly charging and commanding all the Peers of Scotland to assemble and meet at Holyrood House, in Edinburgh, on Friday the third day of June next ensuing, between the hours of twelve and two in the afternoon, to nominate and choose the Sixteen Peers, to sit and vote in the House of Peers in the said ensuing Parliament, by open election and plurality of voices of the Peers that shall be then present, and of the proxies of such as shall be absent, (such proxies being Peers, and producing a man date in writing, duly signed before witnesses, and both the constituent and proxy being qualified according to law,) and the Lord Clerk Register, or such two of the Principal Clerks of the Session as shall be appointed by him to officiate in his name, are hereby respectively required to attend such meeting, and to administer the oaths required by law to be taken there by the said Peers, and to take their votes; and immediately after such elec-tion made and duly examined, to certify the names of the Sixteen Peers so elected, and to sign and attest the same in the presence of the said Peers the electors, and return such certificate into Our High Court of Chancery of Great Britain. And We do, by this Our Royal Proclamation, strictly command and require the Provost of Edinburgh, and all other the Magistrates of the said City, to take especial care to preserve the peace thereof, during the time of the said election, and to prevent all manner of riots, tumults, disorders, and violence whatsoever. And We strictly charge and command that this Our Royal Proclamation be duly published at the Market_Cross at Edinburgh, and in all the county towns of Scotland, twenty-five days, at least, before the time hereby appointed for the meeting of the said Peers to proceed to such election.

Witness Ourself at Westminster, this twentythird day of April one thousand eight hundred and thirty-one, and in the first year of Our reign.
