HIS day, the Lords being met, a message was sent to the Honourable House of Commons by the Gentleman Usher of the Black Rod, acquainting them, that The Lords, authorized by virtue of a Commission under the Great Seal, signed by his Majesty, for declaring His Royal Assent to several Acts agreed upon by both Houses, do desire the immediate attendance of the Honourable House in the House of Peers to hear the Commission read; and the Commons being come thither, the said Commission, empowering the Lord Archbishop of Canterbury, the Lord High Chancellor of Great Britain, and several other Lords therein named, to declare and notify the Royal Assent to the said Acts, was read accordingly, and the Royal Assent given to

An Act to apply the sum of three millions, out of the Consolidated Fund, to the service of the year one thousand eight hundred and thirty-two.

An Act for punishing mutiny and desertion, and for the better payment of the army and their quarters. An Act for the regulation of His Majesty's royal marine

forces, while on shore.

An Act to indemnify such persons in the United King-dom, as have omitted to qualify themselves for offices and employments; and for extending the time limited for those purposes respectively, until the twenty-fifth day of March one thousand eight hundred and thirty-three, to permit such persons in Great Britain, as have omitted to make and file affidavits of the execution of indentures of clerks to attor-pars and solutions to make and file the same an or braneys and solicitors, to make and file the same on or be-fore the first day of Hilary Term one thousand eight hun-dred and thirty-three; and to allow persons to make and she such affidavits, although the persons whom they served shall have neglected to take out their annual certificates.
