That your Majesty's life may be long preserved to your faithful subjects, and that the blessing which, through Divine Providence, they enjoy under your Majesty's beneficent sway, may be transmitted to the latest posterity, are the fervent prayers of, may it please your Majesty, your Majesty's loyal and devoted subjects.
