This day, the Lords being met, a message was sent to the Honourable House of Commons by the Gentleman Usher of the Black Rod, acquainting them, that The Lords, authorized by virtue of a Commission under the Great Seal, signed by his Majesty, for declaring His Royal Assent to several Acts agreed upon by both Houses, do desire the immediate attendance of the Honourable House in the House of Peers to hear the commission read; and the Commons being come thither, the said Commission, empowering the Lord Arch-bishop of Canterbury, the Lord High Chancellor of Great Britain, and several other Lords therein named, to declare and notify the Royal Assent to the said Acts, was read accordingly, and the Royal Assent given to

An Act to apply the sum of eight millions out of the Consolidated Fund to the service of the year one thousand eight hundred and thirty-seven

An Act for continuing, altering, and amending certain Acts for regulating the Police of the city of Edinburgh and the adjoining districts, and for other purposes relating

And several English and four private Acts.
