Copy of a letter from Capt. John Tremayne Rodd, Commander of his Majesty's sloop Scorpion, to Evan Nepean, Esq. dated in the River Humber, April 30.

I Have the honour of acquainting you, for the information of my Lords Commissioners of the Admiralty, that his Majesty's sloop Scorpion, under my command, Flamborough Head, S.W. between two and three miles, fell in with, on the night of the 26th instant, and captured the Batavian Republican brig Le Courier, pierced for 12, and mounting 6 four-pounders, and a number of swivels, commanded by Lieut. Johan Ysbrands, and manned with 30 men, failed eight days before from Helvoetsluys, and taken the Lark brig, of Whitby, coal laden, which the Scorpion Whitby, coal ladel,

Telemachus, Plymouth Sound, May r. Yellerday, in his Majesty's armed cutter under my command, close in with the Bill of Portland, I fell in with and captured, after a chace of twelve hours,

La Sans Souci French privateer lugger, mounting 1 twelve-pounder carronade and 2 brass fours, and 27 men. She sailed from La Hogue the night offore, and had not taken any thing.
