Arthur Wolfe, Chief Justice of his Majesty's Court of King's Bench in this kingdom, in the room of the Earl of Clonnell, deceased; and he was this day fworn into office before the Lord Chancellor accordingly.

His Majesty has also been pleased, by letters patent under the Great Seal aforesaid, to grant the dignity of a Baron of this kingdom to the faid Right Hon. Arthur Wolfe, by the name, style, and title of Baron Kilwarden, of Newlands, in the county of Dublin, and to the heirs-male of his body lawfully begotten.

Copy of a letter from Rear-Admiral Sir Hugh Cloberry Chriftian, K. B. Commander in Chief of his Majefty's fhips and veffels at the Cape of Good Hope, to Evan Nepean, Efg. dated on board the Tremendous, in Simon's Bay, April 29.

Please to acquaint my Lords Commissioners of the Admiralty, that the Indispensable, letter of marque, of 14 guns and 32 men, arrived in Table Bay on the 6th instant, the Master of which informed me of his baving captured, about 35 leagues S. W. of Cape Horn, a Spanish letter of marque, named the Union, carrying 12 guns and 32 men, laden with tallow, hides, and herb-tea. The prize has fince arrived in Table-Bay, was bound from Monto Video to Lima, and is estimated at about 10,000l.
