in named, to declare and notify the Royal Assent to the said Acts, was read accordingly, and the Royal Assent given to An Act for raising the sum of eighteen millions four hundred and seven thousand three hundred pounds, by Exchequer Bills, for the service of the year one thousand eight hundred and forty-four.
