Copy of a Letter from the Right Hon. Lord BRIDPORT, K. B. to EVAN NEPEAN, Esq. dated on board his Majesty's ship Royal George, at Sea, the 15th inst.

SIR,
HEREWITH you will receive a copy of a letter from Sir Edward Pellew, of his Majesty's ship *Indefatigable*, addressed to Vice-Admiral Sir Alan Gardner, stating the capture of the French national corvette *La Vaillante*.

BRIDPORT.
Indefatigable, at Sea,
August 8. 1798.
SIR,
I HAVE great pleasure in communicating to you the capture of the French national corvette *La Vaillante*, commanded by the Lieutenant de Vaisseau La Porte, mounting twenty guns, nine pounders; pierced for twenty-two, and manned with one hundred and seventy-five men.

This ship failed from Rochefort the 1st, and from L'Isle de Rhe the 4th instant, with twenty-five banished priests, twenty-seven convicts, and Madame Rovere and family, for Cayenne. We fell in with her at day-break on the 7th, between Bourdeaux and the isle of Rhe, and the chase continued twenty-four hours, when she struck after firing a few guns. She is of large dimensions, only eighteen months old, coppered and copper fastened, sails fast, and will, I trust, be found fit for his Majesty's service. I have the honor to be, &c.
