WHEREAS by the Act 11th and 12th Victoria, cap. 123, intituled "An Act to renew and amend an Act of the tenth year of Her present Majesty, for the more speedy removal of certain nuisances and the prevention of contagious and epidemic diseases," and by virtue of an Order of Her Majesty's Most Honourable Privy Council, bearing date the 27th day of March 1849, directing that the provisions of the said Act be continued in force throughout the whole of Great Britain;

We, the General Board of Health, are authorised to issue such Directions and Regulations as the said Board shall think fit, for the prevention, as far as possible, or mitigation, of epidemic, endemic, and

contagious diseases.

And Whereas we have been informed that a Vessel lately arrived in the Port of Plymouth having Cholera on board,

We, the General Board of Health, do hereby order and require that the Guardians of the Plymouth Union, or the Guardians of any other Union in whose jurisdiction the case may lie, shall, by themselves or their Officers, enter the said Vessel coming into the said Port in which Cholera or other epidemic disease has occurred, and examine the sanitary condition of the same, and enquire into the health of the crew or crews, and if need be, order cleansing, purification, and all other necessary measures for the prevention of disease, which are authorised or required to be adopted in any dwellings on land, by the General Regulations of the Board, of the 3d and 18th November 1848, issued to the Guardians of the Poor throughout England and Wales.
