Those Ladies and Gentlemen who are to be presented are hereby informed it is absolutely

necessary that Cards with their Names, and the Names of those who are to present them respectively, with their place of Residence thereon, should be sent to this Office, on or before Friday, the 3d of August next, according to the announcement in the Dublin Gazette Extraordinary of Wednesday the 25th instant, in order that they may be submitted for the Queen's approbation, it being Her Majesty's command that no Presentation shall be made either at the Levee or Drawing-Room, but in conformity with the above Regulations.

HEREAS by the Act 11th and 12th Victoria, cap. 123, intituled "An Act to renew and amend an Act of the tenth year of Her present Majesty, for the more speedy removal of certain nuisances, and the prevention of contagious and epidemic diseases," and by virtue of an Order of Her Majesty's Most Honourable Privy-Council, bearing date the 27th day of March 1849, directing that the provisions of the said Act be continued in force throughout the whole of Great Britain; We, the General Board of Health, are authorized to issue such Directions and Regulations as the said Board shall think fit, for the prevention, as far as possible, or mitigation of epidemic, endemic, and contagious diseases.

And whereas it is provided in the fifth section of the aforesaid recited Act, "that nothing hereinbefore contained shall apply to any district or place in which the Public Health Act, 1848, or any part thereof, shall be in force, unless and except in so far as the General Board of Health, by Order in writing sealed with the seal of such Board, and signed by two or more Members thereof, or (in case there be no such Board in existence,) as one of Her Majesty's Principal Secretaries of State, by order in writing under his hand, shall otherwise

direct;"

And whereas it is expedient that the provisions of the said Act shall continue in force in the City of Coventry, for one month after this date, notwithstanding the application of the Public Health

Act to the said city

We, the General Board of Health, do hereby order and declare, that the various provisions and powers of the Nuisances Removal Act shall remain in force in the City of Coventry, for the aforesaid period of one month after the date of this Order.
