AT the Court at Buckingham Palace, the 25th day of June 1851,

PRESENT,

The QUEEN's Most Excellent Majesty in Council.

WHEREAS by an Act passed in the tenth year of the reign of Her Majesty, intituled "An Act for the more easy recovery of small debts and demands in England," it is among other things enacted, that it shall be lawful for Her Majesty, with the advice of Her Privy Council, to order that the said Act be put in force in such county or counties as to Her Majesty, with the advice aforesaid, should seem fit, and to divide the whole or part of any such county (including all counties of cities and counties of towns, cities, boroughs, towns, ports, and places, liberties and franchises therein contained or thereunto adjoining) into districts; and to order that the County Court should be holden for the recovery of debts and demands, under the said Act, in each of such districts; and from time to time to alter such districts as to Her Majesty, with the advice aforesaid, should seem fit; and from time to time, with the advice aforesaid, to declare by what name, and in what towns and places, the County Court should be holden in each district:

And whereas Her Majesty was pleased, by an Order in Council, of the ninth day of March one thousand eight hundred and forty-seven, to order that the said Act be put in force in the counties and places therein specified, and the same was put in force accordingly:

And whereas it hath been represented that it would be to the advantage of the public if certain alterations were made in some of the districts of the Courts, as specified or set forth in the aforesaid Order:

Her Majesty, having taken the premises into consideration, is thereupon pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, that from and after the thirty-first day of July one thousand eight hundred and fifty-one:

That so much of the district of the Clerkenwell County Court of Middlesex as is included within a line drawn from the point where the south boundary of the district of the said Court crosses Whitecross Street, along the middle of Whitecross Street to Old Street, thence along the middle of

Old Street to Bath Street, thence along the middle of Bath Street to the City Road, thence across the City Road to Shepherdess Walk, thence along the middle of Shepherdess Walk, and the road opposite Vaughan's Terrace, Ashley Crescent, and Ashley Terrace, to the Regent's Canal, thence along the middle of the Regent's Canal to the New North Road, thence along the eastern and southern boundary of the district of the said Court, to the point where the said southern boundary crosses Whitecross Street, as first described; and that so much of the district of the said Court as is included within a line drawn from the point where the Regent's Canal is crossed by a bridge called the Rosemary Branch Bridge, leading to Southgate Road, in the parish of Saint John's, Hackney, along the middle of the Southgate Road to Ball's Pond Road, thence along the middle of Ball's Pond Road and Paul's Road to the New River, thence along the middle of the New River until it is crossed by the Green-lanes Turnpike-road, south of Paradise Place, in such road, thence along the middle of the Green-lanes Turnpike-road to the northern boundary of the district of the said Court, thence eastward along the said boundary to the Kingsland Road, thence along the middle of the Kingsland Road to the Regent's Canal, thence westward along the Regent's Canal to the point where the said Rosemary Branch Bridge crosses the said Canal, as first described, shall be within, and form part of the district of the Shoreditch County Court of Middlesex.

That so much of the district of the Shoreditch County Court of Middlesex as is included within a line drawn from the point where the southern boundary of the said Court crosses Brick Lane, along the middle of Brick Lane to Church Street, thence along the middle of Church Street and the Bethnal Green Road to Bethnal Green, thence along the middle of the road on the west and north sides of Bethnal Green to the road opposite Grettton Place, leading to the Old Ford Road, thence along the middle of such road and the Old Ford Road to the Regent's Canal, thence southward along the middle of the Regent's Canal to the southern boundary of the said Court, thence along such boundary to the point where the said boundary crosses Brick Lane, as first described, shall be within, and form part of the district of the Whitechapel County Court of Middlesex.

That so much of the district of the Shoreditch County Court of Middlesex as is included within

a line drawn from the point where the southern boundary of the district of the said Court crosses the Regent's Canal, along the middle of the Regent's Canal to the northern boundary of the parish of Saint Martha, Bethnal Green, thence eastward along the boundary of the said parish to the eastern boundary of the district of the said Court, thence along such boundary to the point where the southern boundary crosses the Regent's Canal, as first described, shall be within, and form part of the district of the Bow County Court of Middlesex.

That so much of the district of the Whitechapel County Court of Middlesex as is included within a line drawn southward from the point where the northern boundary of the district of the said Court crosses the Regent's Canal, along the middle of the Regent's Canal to the southern boundary of the district of the said Court, thence southward along the said boundary to the eastern boundary of the district of the said Court, thence along the eastern boundary and northern boundary of the district of the said Court to the point where the said northern boundary crosses the Regent's Canal, as first described, shall be within, and form part of the district of the Bow County Court of Middlesex.

The parishes of Dinas, Newport, and Llanych-lywydog, now in the district of the County Court of Cardiganshire, holden at Cardigan, and the parishes of Burton, Rosemarket, and Llanstadwell, now in the district of the County Court of Pembrokeshire, holden at Pembroke, shall be in the district of the County Court of Pembrokeshire, holden at Haverfordwest.

The hamlet of Penmaen, now in the district of the County Court of Monmouthshire, holden at Newport, shall be in the district of the County Court of Monmouthshire, holden at Pontypool.

The parishes of Badley, Battisford, Barking, Creeting All Saints, Creeting Saint Mary, Creeting Saint Olave, Earl Stonham, Great Bricett, Little Stonham, Mickfield, Stonham Aspall, and Ringshall; and the hamlets of Needham Market and Darmsden, now in the district of the County Court of Suffolk, holden at Ipswich; and the parishes of Bacton, Cotton, Finningham, Mendlesham, Westhorpe, and Wyverstone, now in the district of the County Court of Suffolk, holden at Eye, shall be in the district of the County Court of Suffolk, holden at Stowmarket.

The parish of Angmering, now in the district of the County Court of Sussex, holden at Worthing, and the parishes of Binsted, Slindon, Walberton, Yapton, and Madehurst, now in the district of the County Court of Sussex, holden at Chichester, shall be in the district of the County Court of Sussex, holden at Arundel.

The parish of Wootton Wawen and Bearley, the townships or chapelries of Henley-in-Arden and Ullenhall, now in the district of the County Court of Warwickshire, holden at Warwick, shall be in the district of the County Court of Warwickshire, holden at Stratford-on-Avon.

The parish of Rise and Long Riston, the hamlet of Rawton, and the township of Arnold, now in the district of the County Court of Yorkshire, holden at Kingston-on-Hull, shall be in the district of the County Court of Yorkshire, holden at

the parishes of Withernwick, Aldbrough, the townships of Great Cowden, Thirtleby, Coniston, Swine, Benningholme, and Grange, the townships of Marton, and North Skirlaugh, and the chapelries of Bilton and South Skirlaugh, now in the district of the County Court of Yorkshire, holden

at Kingston-on-Hull, shall be in the district of the County Court of Yorkshire, holden at Hedon.

The parish of Chigwell, now in the district of the County Court of Essex, holden at Waltham, and the parishes of Stapleford Tawney, Lambourne, and Stapleford Abbots, now in the district of the County Court of Essex, holden at Brentwood, shall be in the district of the County Court of Essex, holden at Romford.

The parish of Newton Solney, and the parish of Repton, including the townships or chapelries of Milton and Bretby, now in the district of the County Court of Derbyshire, holden at Derby, shall be in the district of the County Court of Staffordshire, holden at Burton-on-Trent.

The townships of Taxall, Whaley-cum-Yeardsley, and Kettlethulme, now in the district of the County Court of Cheshire, holden at Macclesfield, shall be in the district of the County Court of Derbyshire, holden at Chapel-en-le-Frith.

That the parishes of Hooe, Herstmonceux, Pevensey, Ninfield, and Wartling, now in the district of the County Court of Sussex, holden at Lewes, shall be in the district of the County Court of Sussex, holden at Hastings.

That the parish of Wednesbury, now in the district of the County Court of Staffordshire, holden at Oldbury, shall be in the district of the County Court of Staffordshire, holden at Walsall.

The parish of Crosby Ravensworth, and the townships of Bolton, King's Meaburn, Morland, Newby, and Sleagill, now in the district of the County Court of Cumberland, holden at Penrith, shall be in the district of the County Court of Westmoreland, holden at Appleby.

The Queen has been pleased to approve of Mr Stefano Scovasso as Consul at Gibraltar for His Majesty the King of Sardinia.

The Lords Commissioners of Her Majesty's Treasury having certified to the Commissioners for the Reduction of the National Debt, in pursuance of the Act 10th Geo. 4th, c. 27, sec. 1; that the actual surplus revenue of the United Kingdom of Great Britain and Ireland, beyond the actual expenditure thereof, for the year ended the 5th day of April 1851, amounted to the sum of two million nine hundred and twenty-six thousand one hundred and eighty-one pounds two shillings and four pence;

The Commissioners for the Reduction of the National Debt hereby give notice, that the sum of seven hundred and thirty-one thousand five hundred and forty-five pounds five shillings and seven pence (being one-fourth part of the said surplus of two million nine hundred and twenty-six thousand one hundred and eighty-one pounds two shillings and four pence) will be applied under the provisions of the said Act, between the 7th day of July 1851, and the 10th day of October 1851, to the following purposes; viz. :—

Wandsworth and Clapham Union.—Wandsworth Parish.

To the Churchwardens and Overseers of the Poor of the parish of Wandsworth, in the county of Surrey ;

To the Clerk or Clerks to the Justices of the Petty Sessions held for the division or divisions in which the said parish is situate ;

And to all others whom it may concern.

Whereas the population of the parish of Wandsworth, in the county of Surrey, according to the last census, exceeds two thousand persons : And whereas at a meeting of the Vestry of the said parish, held, after public notice in that behalf, on the thirteenth day of March last, it was unanimously Resolved—

That the Churchwardens be requested to apply forthwith to the Commissioners for administering the laws relating to the poor of England, that they will be pleased to make an Order under their seal of office, that such portion of the Act 13 and 14 Vict. cap. 57, shall be applied to and be put in force in this said parish of Wandsworth, so far as the same relates to the appointment of a vestry clerk.

And whereas the Churchwardens of the said parish have made their application in writing to us, the Poor Law Board, pursuant to the above Resolution.

Now therefore, we, the said Poor Law Board, under the authority of the several Statutes in that behalf made and provided, do hereby order and direct, that so much of the Act aforesaid, passed in the fourteenth year of the reign of Her Majesty, intituled " An Act to prevent the holding of vestry or other meetings in churches, and for regulating the appointment of vestry clerks," as relates to the appointment of a vestry clerk, shall forthwith be applied to, and be put in force within the said parish of Wandsworth.

And, at the request of the said Churchwardens, we do hereby prescribe and direct that, in addition to the duties of the vestry clerk, set forth in the said Act, it shall be the duty of such vestry clerk—

To assist the Churchwardens and Overseers, when required by them, in conducting any proceedings for polling, in the election of officers for the said parish :

To attend, twice a year, the Churchwardens and Sidesmen, at the ecclesiastical visitations of the said parish, and to prepare a draft of each presentment made at any of such visitations, on the day of the presentation of the same :

To attend the Churchwardens and Overseers, or any of them, at every septennial perambulation of the boundaries of the said parish, and to make minutes of the proceedings thereof :

To prepare all reports of Committees appointed by the Vestry of the said parish to inquire into any matter concerning the said parish.

And we do hereby Order and direct that a copy of this Order shall be published in the London Gazette.

Ulster then announced that Lord Viscount Massereene and Ferrard was in attendance, and His Excellency directed that his Lordship should be introduced to receive the honour of Knighthood; his Lordship was then introduced between the Gentleman Usher and Ulster King of Arms, and kneeling on his right knee, His Excellency conferred on him the honour of Knighthood, after which his Lordship retired.

By Command of the Grand Master, the two Junior Knights present proceeded to the door of the Chapter Room, and, preceded by the Officers of the Order, Ulster bearing the Insignia on a velvet cushion, conducted the Viscount to the right of the Chair of State, where his Lordship made and subscribed the declaration appointed by the Statutes, and His Excellency the Grand Master, assisted by the two Senior Knights Companions present, put the Ribbon and Badge over the right shoulder, pronouncing the Admonition directed by the Statutes, after which the Viscount was congratulated by His Excellency and the Knights present, and took his seat at the table.

Ulster then, by His Excellency's Command, called over the names of the Knights Companions, who each rose from his seat on the pronouncement of his name, and the Chapter broke up.

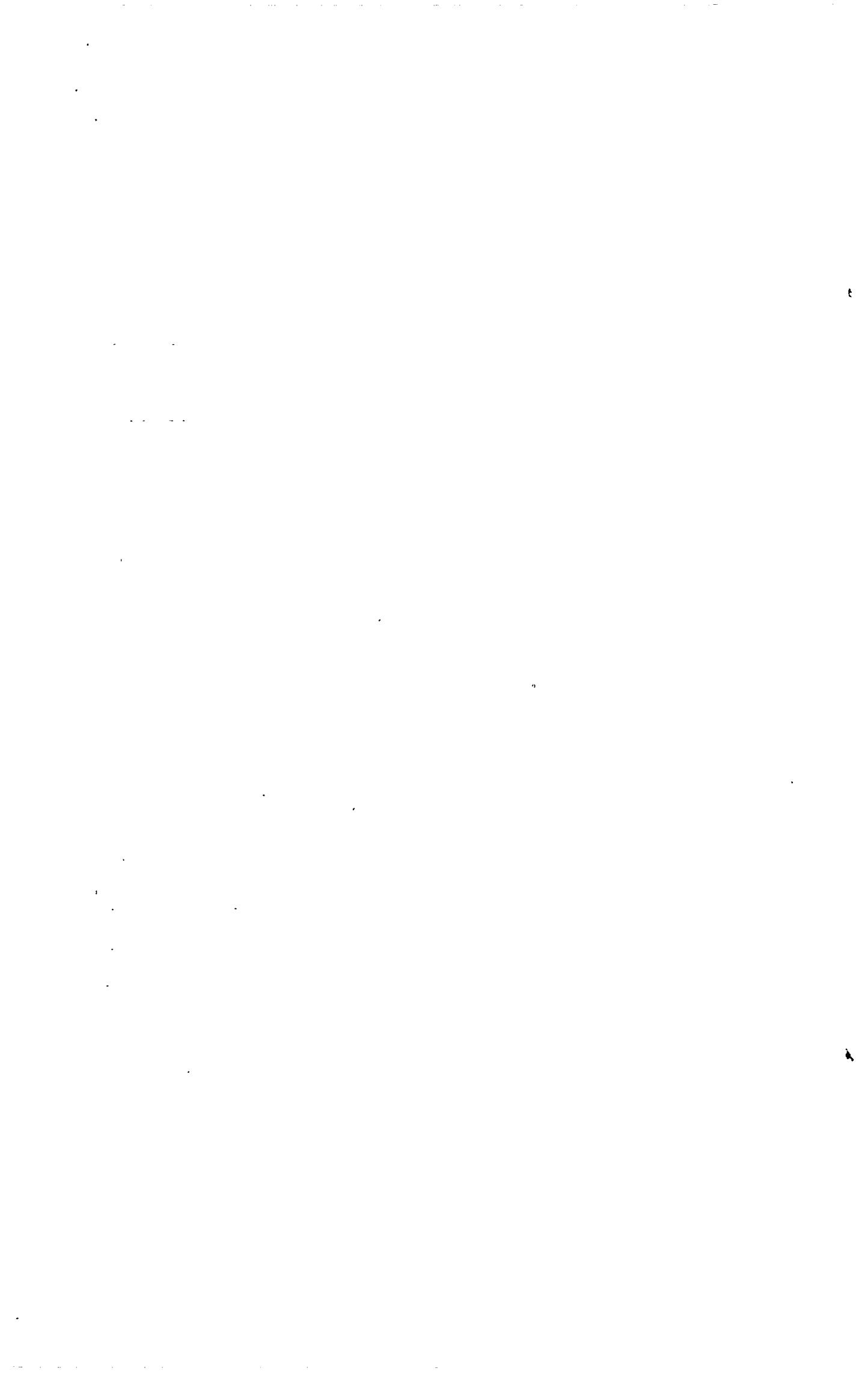
