A DISPATCH has been this day received by Viscount Palmerston, Her Majesty's Principal Secretary of State for Foreign Affairs, from the Honourable George Edgcumbe, Her Majesty's Chargé d'Affaires at Hanover, announcing the melancholy intelligence of the decease of His Majesty the King of Hanover, which took place at Hanover at a quarter before seven o'clock on the morning of the 18th instant.

The Gentlemen to wear Black full trimmed, fringed or plain Linen, black Swords and Buckles.

The Court to change the Mourning on Sunday the 7th of December next; viz:—

The Ladies to wear black Silk or Velvet, coloured Ribbons, Fans and Tippets, or plain white, or white and gold, or white and silver Stuffs, with black Ribbons.

The Gentlemen to wear black Coats, and Black or plain White, or white and gold, or white and silver Stuff Waistcoats, full trimmed, coloured Swords and Buckles.

And on Sunday the 14th of December next, the Court to go out of Mourning.

And whereas at a meeting of the Vestry of the said parish, held at the vestry-room of the said parish, after due notice thereof, on Thursday the fourth day of September last, it was resolved-

"That a Vestry-Clerk be appointed; and we "recommend the salary of eleven pounds five "shillings per annum to be paid from the "twenty-fifth day of March last; also that "he should be required to perform generally "the duties of a Vestry Clerk, according to "the provisions of 13 and 14 Vict., c. 57; " and that this Vestry do not think it neces-" sary to require a security."

And whereas the Churchwardens of the said parish have made their application in writing to the Poor-Law Board, pursuant to the above Resolution.

Now, therefore, we, the said Poor-Law Board, under the authority of the several Statutes in that behalf made and provided, do hereby order and direct as follows; that is to say:—

ART. 1. That so much of the foresaid Act as relates to the appointment of a Vestry Clerk shall forthwith be applied to, and be put in force within, the said parish of Llanasa.

ART. 2. That a copy of this Order shall be published in the London Gazette.
