DUBLIN-CASTLE, November 18, 1851.

This day His Excellency the Earl of Clarendon, Grand Master, by Her Majesty's Command, held a Chapter of the Most Illustrious Order of Saint Patrick.

There were present the Earls of Charlemont, Howth, Miltown, Rosse, and Fingal; Viscount Massareene; His Grace the Archbishop of Dublin, Chancellor ; the Very Rev. the Dean of St Patrick's, Registrar ; Lt.-Col. the Hon. Robert Boyle, Secre-tary ; Col. Sir George Morris, Usher of the Black Rod; and Sir William Betham, Ulster King of Arms and Knight Attendant.

The Knights Companions, in their Mantles and Collars only, and the Officers of the Order in their Mantles, Ribands, and Badges, assembled in the Entrée Room of Dublin Castle.

At two o'clock the Knights were called over by Ulster, and, preceded by the Officers of the Order, proceeded to the Chapter Room, where His Excellency the Grand Master was seated in the Chair of State, and the Knights Companions took their places at the table according to their respective Stalls.

His Excellency then commanded Ulster King of Arms and Knight Attendant, to read Her Majesty's Letter authorizing the Chapter to be held, which being done, His Excellency communicated to the Chapter that, in obedience to Her Majesty's Commands, the Chapter would proceed to invest His Royal Highness Sir George Duke of Cambridge, K G., and the Right Hon. Robert Shapland Baron Carew, with the Riband and Badge of the Most Illustrious Order.

Ulster then announced that His Royal Highness the Duke of Cambridge was in attendance, where-upon His Excellency requested the two Junior Knights, the Earl of Fingal and Viscount Massa-reene, to introduce His Royal Highness, who accordingly retired to the Entrée Room and shortly returned with His Royal Highness, (Ulster bearing before them the Insignia of the Order on a velvet cushion,) conducted him to the right of the Chair of State, when His Royal Highness repeated after the Archbishop of Dublin, Chancellor of the Order, the Declaration appointed by the Statutes, which he subscribed, and His Excellency, assisted by the two Senior Knights, then placed the Riband and Badge over the right shoulder, pronouncing the Admonition appointed by the Statutes, after which

His Royal Highness was congratulated by His Excellency and the Knights present, and took his seat at the table.

Ulster then announced that the Right Honorable Robert Shapland Baron Carew, was in attendance, and His Excellency directed that his Lordship should be introduced to receive the honour of Knighthood, on which he was introduced between Ulster King of Arms and the Gentleman Usher, and kneeling on his right knee, His Excellency conferred upon him the honour of Knighthood, after which his Lordship retired into the Entrée Room.

His Lordship was then introduced by the two Junior Knights present, and invested, with the same ceremonies.

Ulster then, by His Excellency's command, called over the names of the Knights Companions present, beginning with the Junior, who each rose from his seat as his name was pronounced, and the Chapter broke up.
