REGULATIONS TO BE OBSERVED AT THE QUEEN'S LEVEE, AT ST JAMES'S PALACE.

The Noblemen and Gentlemen who purpose to attend Her Majesty's Levee at St James's Palace, are requested to bring with them two large cards, with their names clearly written thereon, one to be left with the Queen's Page in Attendance in the Presence-chamber, and the other to be delivered to the Lord Chamberlain, who will announce the

name to Her Majesty.

Those Gentlemen who are to be presented are hereby informed it is absolutely necessary that their names, with the name of the Nobleman or Gentleman who is to present them, should be sent in to the Lord Chamberlain's Office, on the Monday previous to the Levee on the 3d of March next, before twelve o'clock, in order that they may be submitted for the Queen's approbation; it being Her Majesty's command, that no presentation shall be made at the Levee but in conformity with the above Regulations.

It is particularly requested that in every case the names be very distinctly written upon the cards to be delivered to the Lord Chamberlain, in order that there may be no difficulty in announcing them

to the Queen.

The State Apartments will not be open for the reception of Company coming to Court until halfpast one o'clock.

Notice is hereby given, that all persons having Petitions or Addresses to present to Her Majesty at the Levee, are to send a card (having on it their names, a statement of the object of such Petitions or Addresses, and the names of the persons from whom they come,) to the Lord Chamberlain's Office, before twelve o'clock on the Monday previous to the Levee on the 3d of March next; and that two other cards, having on them precisely what is written upon that sent to the Lord Chamberlain's Office, are to be taken to the Levee; one of the two cards to be delivered to the Page in the Ante-Room, and the other to the Lord Chamberlain, who will read its contents to Her Majesty; and, on these occasions, no other statement is to be addressed to Her Majesty.

A Deputation to present an Address is not to exceed four persons.

In exercise of the powers given to them by the 18th Section of the Mercantile Marine Act Amendment Act, the Lords of the Committee of Privy Council for Trade have dispensed with so much of the Act 7 and 8 Vict., c. 112, s. 18, as relates to the use of Lime, or Lemon Juice, Sugar, or Vinegar, in ships bound to any ports on the eastern coast of North America, north of the 35th degree of north latitude, whether such ports are in the British Colonies or in the United States, or to any ports situate in Islands in the Atlantic Ocean north of the same limits.
