THIS Afternoon, at Five Minutes past Five o'Clock, Her Most Gracious Majesty The Queen, accompanied by His Royal Highness The PRINCE ALBERT, and Their Royal Highnesses The PRINCE of WALES, The PRINCESS ROYAL, PRINCESS ALICE, PRINCE ALFRED, and PRINCESS HELENA, and Suite, arrived at Her Majesty's Royal Palace of Holyrood.

On Her Majesty's entering the Palace a Royal Salute was fired from the Guns of the Castle.

Elland-cum-Greetland Township.

To the Churchwardens and Overseers of the Poor of the township of Elland-cum-Greet-land, in the county of York;

To the Clerk or Clerks to the Justices of the Petty Sessions held for the division or divisions in which the said township is situate;

And to all Others whom it may concern.

Whereas the population of the township of Elland-cum-Greetland, in the county of York, according to the last census, exceeds two thousand persons,

And whereas at a meeting of the Vestry of the said township, held, after due notice, on Friday the second day of January one thousand eight hundred and fifty-two, it was resolved-

"That the Poor Law Board be requested to "issue an Order under their seal of office, "directing that the Act passed on the 5th "August 1850 (13 and 14 Vict. c. 57), "intituled 'An Act to prevent the holding of Vestry or other Meetings in Churches, and for regulating the appointment of "Vestry Clerks,' shall be applied to, and put "in force within this township, as regards "that portion of it only which relates to the " providing of accommodation for holding
" Vestry Meetings."

And whereas the Churchwardens of the said township have made their application in writing to the Poor Law Board, pursuant to the above Resolution:

Now therefore, We, the said Poor Law Board, under the authority of the several Statutes in that behalf made and provided, do hereby order and direct as follows; that is to say:—

ART. 1. That so much of the aforesaid Act as relates to the providing of a room for the purpose of holding any vestry and other meetings, for the transaction of any business of or relating to the said township of Elland-cum-Greetland, shall forthwith be applied to, and be put in force within the said township.

2. That a copy of this Order shall be published in the London Gazette.
