#### HOLYROOD PALACE, 13th October 1852.

THIS Morning, at Eight o'Clock, Her Most Gracious Majesty THE QUEEN, accompanied by His Royal Highness The Prince Albert, and Their Royal Highnesses The Prince of Wales, The Princess Royal, Princess Alice, Prince Alfred, and Princess Helena, and Suite, took their Departure from Her Majesty's Royal Palace of Holyrood, for London, via North Wales.

On Her Majesty's Departure a Royal Salute was fired from the Guns of the Castle.

The Queen has also been graciously pleased to appoint Charles Wilthew, Esq. to be Her Majesty's Consul at Acapulco.

#### OFFICE OF ARMS, DUBLIN-CASTLE, October 9, 1852.

The Queen has been graciously pleased, by Warrant under the Royal Signet and Sign Manual, bearing date at Saint James's, the 15th day of September 1852, to give and grant to Hugh Brabazon Higgins, of Brabazon Park and Swinford, in the County of Mayo, Esquire, late a Captain in the 15th Regiment of Hussars, Her Majesty's royal licence and authority, that he and his issue may take and bear the sirname of Brabazon only, and may bear the arms of Brabazon in the first quarter of their family arms; provided Her Majesty's royal concession and declaration be recorded in the Office of Ulster King of Arms, in Ireland, which has been done accordingly.
