### PUBLIC FUNERAL OF THE LATE FIELD-MARSHAL ARTHUR, DUKE OF WELLINGTON, K.G.

WHE QUEEN having been pleased to declare Her Royal will and pleasure that the Interment of the late Field-Marshal Arthur, Duke of Wellington, K.G., should be solemnized in the Cathedral Church of St Paul with all the honour due to his eminent public services and transcendant merits, the EARL MARSHAL received the Royal Command for the purpose of carrying into effect Her Majesty's pleasure accordingly.

The Military Arrangements were under the immediate direction of Viscount Hardinge, G.C.B., the General Commanding-in-Chief.

On Wednesday evening, the 10th November, at seven o'clock, the remains of the late illustrious deceased were privately removed from Walmer Castle, in a Hearse drawn by four horses, attended by an escort of the Rifle Brigade, and followed by three Mourning Coaches, each drawn by four horses, attended by the first of which were the Marquess Douro (now Duke of Wellington), Lord Arthur Hay, and the Captain of Walmer Castle (John J. Watts, Esq.); in the second, Thomas Charles March, Esq. Chief-Clerk of the Department of the Lord Chamberlain of Her Majesty's Household; and in the third, Mr Kendall and Mr Collins, servants of the deceased: Minute Guns were fired from the ramparts of Walmer Castle whilst the Procession moved from thence to the Station at Deal. From the Station the Bedra ettended by the Marquess Douro and the other persons who had followed in the Meumine the Body, attended by the Marquess Douro and the other persons who had followed in the Mourning Coaches, was conveyed by Special Train to London, arriving there at twelve o'clock ; and thence, being followed as before, the Body was conveyed under an escort of Life Guards to Chelsea Hospital, where, about three o'clock in the morning of Thursday the 11th, it was received by Norman Hilton Macdonald, Esq., Comptroller of the Lord Chamberlain's Department, and by a Guard of Honour of the 2d Battalion of Grenadier Guards, under the command of Lieutenant-Colonel the Honourable James Lindsay; and a similar Guard of Honour, furnished by the brigade of Foot Guards, mounted daily, until the Remains were removed.

The Remains lay in State in the Great Hall of the Royal Hospital at Chelsea ; the arrangements

The Remains lay in State in the Great Hall of the Royal Hospital at Chelsea; the arrangements being under the direction of the Lord Chamberlain. The Octangular Vestibule, leading to the Great Hall, was hung with Black Cloth in the form of a Tent, and illumined by a Chandelier of eighteen lights, suspended from the Ceiling. On the side opposite the entrance was a Trophy of thirty Flags, from the Hall of the Hospital, and grouped around the Royal Arms, the whole being surmounted by the Royal Standard of England. On the other side of the Vestibule were Escocheons of the deceased. The Walls of the Hall were hung with Black Cloth, decorated with the Armorial Escocheons of the deceased and the Ceiling there are with the same numerical to represent a Tent. The width of the

the deceased, and the Ceiling draped with the same material, to represent a Tent. The width of the Hall was divided into five parts by four rows of colossal Candelabra, and at the upper or western end was a Dais, reaching across the whole width, having on it twelve Candelabra of four lights each, and ten Columns composed of Spears, covered with Black Velvet, powdered with Laurel Wreaths and Escocheons. The Coffin, covered with Crimson Velvet, was raised upon a Bier on which was a Black Velvet Pall garnished with Escocheons, and at its foot were suspended the Insignia of the numerous Orders of Knighthood conferred upon the illustrious deceased. Upon Pedestals projecting from the Rail surrounding the Bier, were arranged upon Black Velvet Cushions, the British and Foreign Field-Marshals' Batons of the late Duke, surmounted by the respective National Flags; and upon others, at the head of the Coffin, were placed the Great Banner, and the Banner of Wellesley; the Guidon, the Standard, and the Bannerols of the lincage of the deceased were ranged on either side the Bier, and the Majesty Escocheon (upon a Cloth of Gold), was suspended from the Wall at the head of the Coffin. In front of the Dais was a trophy of the Surcoat, Sword and Targe, Helm and Crest, and the Spurs of the deceased. Over the Bier was a Canopy of Black Velvet (lined with Silver Tissue and enriched with Silvered Cornice and Vallance, Escocheons, Pennons, and Plumes), from which depended four Curtains, also of Black Velvet (similarly lined), edged with Silver Lace.

On the afternoon of the 11th November, the following officers of the Grenadier Guards, viz.— Colonel Godfrey Thornton (commanding Grenadier Guards), Lieutenant-Colonel Hon. James Lindsay, Major Studholme Brownrigg, and Captain Cuthbort George Ellison, with 100 rank and file of the First Battalion, attended at the Hall of the Royal Hospital. The Officers of the Guard, and of the Lord Chamberlain's Department, were seated as Mourners about the Coffin, and 50 men lined either side of the Hall, resting on their Arms reversed, both Officers and men remaining till the Hall was cleared.

On Friday, November 12, were admitted to the Hall, by tickets from the Lord Chamberlain, the Foreign Ambassadors and Ministers, Peers and Peeresses, Members of Parliament, Officers of the Army and Navy, and such other persons as the Lord Chamberlain decmed entitled to the privilege.

On Saturday, November 13, and from Monday, November 15, to Wednesday, November 17, the Public were admitted, without restriction, from nine o'clock in the morning until four o'clock on the afternoon of each day.

On each day of the public admission a detachment from one or other of the Battalions of Foot Guards in London attended to perform a like duty to that of the Grenadier Guards on the 11th, the Officers in command of each detachment, and the Comptroller of the Lord Chamberlain's Department, being seated alternately at the head of the Coffin, whilst other Officers of the Guard, with those of the Lord Chamberlain, sat on either side, being relieved every two hours; Warders of the Tower were stationed on the Dais, during the whole time of the Lying-in-State. A Captain's Guard of the 1st Regiment of Life Guards was mounted daily at the Hospital during the Lying-in-State, and twenty troopers of the same lined the Vestibule leading to the Hall, being relieved every hour.

At eleven o'clock on the night of Wednesday the 17th, the Body was removed, in the presence of the Marquess of Exeter, Lord Chamberlain, and Norman Hilton Macdonald, Esq. Comptroller of the Lord Chamberlain's Department, and conveyed (in a Hearse drawn by four horses) to the Horse Guards, being attended by an escort of Life Guards, and followed by two Mourning Coaches, the one containing Thomas C. March, Esq. Chief-Clerk of the Lord Chamberlain's Department, and the other, Mr Kendall and Mr Collins, servants of the deceased. On arrival at the Horse Guards, the Body was placed in the Audience Chamber there, which had been previously prepared for the purpose.

ON THE MORNING of the 18th, the Troops assembled in St James's Park, under the command of Major-General His Royal Highness the Duke of Cambridge, K. G., to whom the following Staff was attached :-

who performed the duties of the Adjutant and Quarter-Master General's Departments, under His

Royal Highness; and Lieutenant-Colonel Lord William Paulet, Unattached; Lieutenant-Colonel Lord George Paget, 4th Light Dragoons; Lieutenant-Colonel Tyrwhitt, Scots' Fusilier Guards; and Captain His Serene Highness Prince Edward of Saxe-Weimar, Grenadier Guards, acted as His Royal Highness's Aides-de-Camp.

The Military force appointed for this duty consisted of

17 Pieces of Artillery

8 Squadrons of Cavalry,

and 6 Battalions of Infantry.

The Infantry was formed on the Parade in front of the Horse Guards, at half-past seven o'clock, in the following order :-

The 1st Battalion Grenadier Guards on the right, near the Cadiz Mortar; the Battalion of the Rifle Brigade on the left, near the long gun ; in contiguous columns at quarter distance, right in front, facing the Horse Guards. Bands in rear of respective Battalions.

At a quarter before eight o'clock 19 Minute Guns were fired in the Park.

The six Battalions of Infantry took open order, Officers in front. When the sides of the tent, in which the Coffin and Car had been placed, were drawn, the Infantry presented Arms, and after an Interval reversed Arms. in readiness to move off.

The Artillery and Cavalry at the same time carried Swords.

This disposition being made, the troops moved off at eight o'clock precisely, proceeding up Con-stitution Hill, through Piccadilly, by St James's Street, along Pall Mall, Cockspur Street, Charing Cross, and the Strand, to Temple Bar, and thence to the Cathedral Church of St Paul, in the follow-Infantry, six Battalions. ing order :-

During these operations, His Grace the Archbishop of Canterbury, the Earl Marshal, with the Great Officers and Ministers of State, and other Official Personages; the Lords Chief Justices, the Lord Chief Baron, the Lords Justices of Appeal, the Knights Grand Cross, Knights Commanders, and Com-panions of the Bath, the High Sheriff of the County of Southampton, Chaplains and Physicians, the Comptroller of the deceased's Household, and the several Deputations and Delegations taking part in the Procession, had assembled in St. James's Park (having been admitted at Buckingham Gate, or Storey's Gate, by tickets from the Earl Marshal), and formed, under the direction of the Officers of Arms, in the open space in front of the Horse Guards, in numerical order, according to the number on the Card with which each Coachman had been furnished.

The Officers representing the Army of Brunswick, and those deputed to carry the Foreign Batons of the deceased, the Marquess of Anglesey, the General Officers nominated to support the Pall, the Chief Mourner, with his Supporters and Train-bearer, the Assistants to the Chief Mourner, Relations and Friends of the deceased, had been received in rooms provided for them at the Horse Guards, and were severally conducted by Sir Charles George Young, Garter, to the Mourning Coaches, ranged in numerical order, on the side towards the Admiralty.

The officers appointed to carry the Standard, Guidon, Banners, and Bannerols, assembled upon the Parade, where their respective Banners were delivered to them.

The Procession thus formed, moved onward in the following order :-

The Carriage of the Right Honourable the Lord Mayor, who bore the City Sword, was placed between the Carriages of His Royal Highness Prince Albert and that of the Archbishop of Canterbury. Upon the Rifle Battalion reaching the point where it was to line the street, the left wing drew up

on the left side of the street, the right wing fronting it. The Battalion of the Royal Marines passed, and formed on the left of the Rifle Battalion, followed

by the 33d Regiment, fronting the Marines. The 1st Battalion Scots' Fusilier Guards formed on the left of the Marines, the Coldstream Bat-

talion fronting the Fusiliers.

The 1st Battalion Grenadier Guards formed with its left wing on the Fusilier Guards, and its right wing on the Coldstream Guards, at the further end of Ludgate-hill, detaching the two flank companies to join the flank companies of the 2d and 3d Battalions, previously posted within the railing of St. Paul's Church-yard.

The Artillery and Cavalry marched through the line of Infantry, and moved by the south side of St Paul's to their respective posts.

Upon the Funeral Car reaching the flank of each Battalion, the Battalion presented, reversed, and rested upon its arms, till the Carriage of the Chief Mourner had passed its flank. The Detachments from every Regiment, headed by Major-General George Augustus Wetherall,

marched with their side arms, six in front, in single ranks, through the Infantry ; passing round the south side of St. Paul's, to the post assigned to them.

Upon arrival at Saint Paul's Cathedral the Marshalsmen and Conductors divided and ranged themselves on each side of the foot of the steps without the Great West Door; the Chelsea and Enrolled Pensioners, together with one Soldier from every Regiment in Her Majesty's Service, the Royal Marines, and six Soldiers of the East India Company's Armies of Bengal, Madras, and Bombay (two Officers from every Regiment having been previously provided with seats in the Nave behind the place assigned to the Soldiers), proceeded into the Nave and filed off right and left.

Upon their arrival at the Western Entrance of the Cathedral, the Field Officers, carrying the Standard, Guidon, Banners, and Bannerols were relieved ; the General Officers appointed to carry them in the Church, and who had been provided with seats in the Centre Area, were conducted down the Nave to receive them by Mr Courthope, Rouge Croix Pursuivant of Arms, in attendance at the Cathe-dral for that purpose. The Common Council, Sheriffs, Recorder and Aldermen of London proceeded to their own seats on the North side of the Area; the Military Secre-tary, the Companions, Knights Commanders, and Knights Grand Cross of the Order of the Bath, representing that Most Honourable Order, were conducted to the seats appropriated to them; the Lords Justices of Appeal, the Lord Chief Baron, and the Lords Chief Justices, the other Official Personages, Ministers, and Great Officers of State, proceeded to the seats appropriated to them respectively.

His Royal Highness Prince Albert, carrying his Baton as Field-Marshal, preceded by the Lord Mayor bearing the City Sword, passed to the Centre Area and took his seat on the right hand of the Chief Mourner; the Lord Mayor stood near II.R. Highness; the Suite of His Royal Highness took their places near His Royal Highness. His Royal Highness the Duke of Cambridge occupied a Chair near His Royal Highness Prince Albert ; his Staff remaining near His Royal Highness.

The Body, when taken from the Car, was received at the Great Western Entrance by the Bishop of London, the Dean, Canons, and Prebendaries of the Cathedral, together with the Minor Canons and Choir. Upon moving up the Nave the Minor Canons, Vicars Choral, &c., commenced singing the sen-tences in the Office for Burial, "I am the Resurrection and the Life."

The Supporters of the Pall were seated on each side of the Body. The Officers bearing the Bannerols were ranged on either side behind the Supporters of the Pall.

The CHIEF MOURNER was seated in a Chair at the head of the Body ; his Supporters on either side; the Train-bearer was seated behind, with the Lord Charles Wellesley on the right, and the Hon. and Rev. Gerard Wellesley on the left; behind them, the Assistants to the Chief Mourner, Relations and Friends of the deceased, were also seated.

The Foreign Batons were held and supported during the Ceremony by the distinguished persons before named, who, with the Marquess of Anglesey and the Officers representing the Army of Brunswick, occupied seats at the foot of the Coffin.

The Body being placed on a Bier, and the Pall removed, the Hat and Sword were taken from the Coffin. and the Coronet and Cushion placed thereon, as also the deceased's Baton as Field-Marshal of the British Army

The Choir then chanted the 39th Psalm, "Dixi Custodiam," and the 90th Psalm, "Domine Refugium," (the music of the two Psalms composed by the Earl of Mornington), immediately after which an Anthem was sung (the music by Mr John Goss, Organist of Saint Paul's); the Dean, Dr. Milman, then read the Lesson, after which "Nunc Dimittis" (the music by Beethoven) was chanted, followed by a Dirge, accompanied by Trumpets (the music also by Mr Goss). The Dirge being concluded, the Body was lowered into the Vault, amid the solemn strains of the Dead March, after which the Choir sang "Man that is born of a woman," and other sentences (music human for any Burnell)

by Croft and Purcell).

After the committal, the whole choir sang the sentence "I heard a voice from Heaven," (music by Croft); the remainder of the Service followed; and at the conclusion of the Collect was sung the Anthem "His body is buried in peace" (from Handel's Funeral Anthem), and the Burial-Service being ended, Garter advanced from his place at the foot of the coffin, and proclaimed the Style of the deceased, as follows :-

The Comptroller of the Household of the deceased then advanced, and breaking his Staff, delivered the pieces to Garter, by whom they were deposited in the Grave.

The Hymn, "Sleepers awake," (the music by Mendelssohn), was then sung, and upon its con-clusion, the Lord Bishop of London pronounced the Blessing; after which, upon a signal given, the Guns at the Tower fired, and the Trumpets sounded a wail at the Western Entrance of the Cathedral, which concluded the Ceremony.

Mr Goss presided at the Organ, and Mr Turle, Organist of Westminster Abbey, led the Choir.

#### Knights of the several Orders wore their Collars.

The Queen's royal will and pleasure for the Public Interment of the Duke of Wellington having, by Her Majesty's command, been communicated to Parliament, it was determined by both Houses that they would attend the Solemnity in the Cathedral, the House of Lords being represented in the Procession by the Lord Chancellor, and the House of Commons by their Speaker; the Members of both Houses accordingly repaired to St Paul's by eleven o'clock, where galleries had been provided for their reception in the Centre Area, one on the south side for the Peers (where also the eldest sons of Peers were provided with seats in the back row,) and one on the north side for the House of Commons

A gallery immediately in front of the Choir was erected for the Peeresses who had signified their wish to witness the Solemnity, each accompanied by a lady; where also were scated the wives of the Cabinet Ministers present, as also the Lady Mayoress.
